My dear Friend:

When your letter of recent date came to me the Indian Office's eye specialist was engaged in examining our students and so there has been some delay in getting this report to you. I am pleased to say, however, that your sister's eyes are not seriously affected and that with the treatment we are prepared to give she should not be inconvenienced further with eye trouble.

Blanche is one of the girls who is affected with trachoma, a disease of the eye now quite prevalent among the older Indians of the west. The operation about which you had heard consists only of scraping the eye-lids to remove the granular growth of which trachoma consists. The after treatment will require some months, but it will mean little inconvenience to Blanche and she can go ahead with her school work as usual. I desire to say further that your sister is one of those girls who has trachoma in its first stage and that her sight has not become weakened in

any way by it. The treatment that will be given her is prescribed by an eye expert sent here by the Office at Washington, and I assure you that the best of care will be given her.

I have given that part of your letter in which you speak about your failure with flax last year my careful thought, and, though I am sorry to learn that you did not get any returns for the summer's work, I believe I am best pleased with the determination you are showing to try it again. There must be failures in anything we undertake and the fellow that wins out is the one who has the courage to try again and again. No matter how many may be the failures, the next year may be the banner year and the beginning of succeeding years of prosperity. You have my best wishes for success, and the spirit with which you start in this spring will go a long way toward making your summer a pleasant one, which, I trust, will be made the more pleasant by a bountiful harvest.
