6. What property in the way of land, stock, buildings or money do you have? Unsettled.

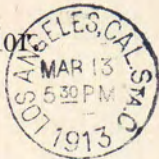
7. Have you been in the Indian Service? In what positions? How long in each?

My dear Friend:

Mrs. Denny referred your letter of the 15th instant to me and I have noted that part of it in which you recommend Miss Alma Herman for enrolment at Carlisle. On Monday of this week a letter was received from Miss Herman direct, but I have had to inform her that she should first apply for enrolment at the Salem School at Chemawa, Oregon, or the Sherman Institute at Riverside, California.

If it cannot be arranged, however, to enroll Miss Herman at either of the schools named I will gladly submit to the Commissioner of Indian Affairs a full justification of her need of aid from the Government to continue her education.

We are especially well prepared at Carlisle to give training in Nursing and so located that the special training in the larger city hospitals can be arranged for girls who show special qualifications.

It is hoped that your friend can become enrolled in one of the schools named above and that both of you will not hesitate to let me hear from you if I can be of service in any other way.

She is very ambitious and studious. She is very musical and promising in every way. She says she wants to take up nurse training in the hospital, school teaching and music, especially.

she had never been to any government school. She would like to know if the government would afford to pay her <sup>her</sup> fare. If not, she says she is willing to save her own money and pay her own transportation.

Mrs. Penny, I certainly think that if the superintendent permits her as a student he would have a fine pupil. She is very anxious to advance her self to able to earn her living better after she finishes. I hope that he will let her enter Carlisle as a pupil.

now she is working in a private family in San Francisco.

Sometimes I think that I should have taken a special course of some kind when I was in school, so that I could make my living more comfortably and easily. I have been working in the private families since I left school and I am getting tired of it now. Housework is hard work and there is only a little money at the end of the month. Unless a girl is really born for that work for permanent there is a lot change and no success coming in the future.

Answering your letter of January 27, you are informed that before you would be eligible for appointment as Assistant Matron at a salary of more than \$300 a year, it will be necessary for you to pass a noncompetitive examination, which the Civil Service Commission has been asked to grant you to take place at Los Angeles under the direction of the Postmaster. However, Indians are eligible for appointment as laundress and cook without examination.

You should fill out and return the enclosed Indian applicant blank through the Superintendent of the Carlisle School, in order to complete the record in your case.
