7. Have you been in the Indian Service? In what positions? How long in each? have never been any Indian service of any kind

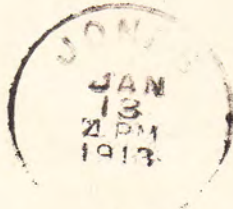
8. What other positions have you held since leaving Carlisle? *No other*
