My dear Madam:

Your letter of very recent date has been received here and it is noted that you must find a place where your seven year old son can be cared for. Noting also that you are anxious to have him enrolled at Carlisle, I must state that we are no longer in a position here to care for boys as young as that. During the past year an effort was made to enroll only those more than sixteen years of age and it is now a ruling that if students less than fourteen years of age are sent here with an older child from the same family special authority must be secured to effect the enrolment.

In view of the fact that Father L. A. Deering, now located at 242 South 20th Street in Philadelphia, has always taken a great deal of interest in the students who were at one time enrolled at Carlisle from Porto Rico it is suggested that you write to him for advice and help in regard to placing your boy in some school.

Trusting that you will succeed in finding a suitable

My dear Friend:

Your last letter has been held here for some time in order that the renewed request contained therein could be given consideration. Finally it has been decided that it will not be advisable to co-operate with you in finding a place for the boy in whose welfare you have interested yourself for the reason that, sooner or later, the special arrangements under which he would have to be placed under our outing system would result in difficulty of one kind or another.

However, if it can be arranged to enroll him here under the usual arrangements everything possible will be done to give him the privileges you desire for him. Tuition at the rate of \$167.00 per year would have to be paid, after authority for the enrolment had been secured from the Office at Washington.

Hoping it will yet be possible to help the boy you mention, I remain, Very truly yours,
