of age when I left Carlisle but that did not
end my school-days. With the delight in
seeing the many graduates there each year
gave me encouragement and hoped that
some day I may be as "lucky." I con-
tinued my schoolwork and in 1906 entered
Training School for Nurses and graduated
June 17, 1909, also expect soon to become
member of Penna. State Registration for Nurses
For the last six months have held position
as night Supt. in our hospital. I highly
appreciate Carlisle for the start it gave me
and hope it will benefit my brothers Torrence
and Hobart as well.

I feel it quite necessary for me to write you concerning my little brothers Torrence and Robert both under your charge in the small boys quarters. Very often I receive letters from them which are not

satisfactory at times,
they complain of ill-treatment
from you, that is harsh
punishment they receive
for probably a trivial dis-
obedience. Now for
instance in Torrence's letter
to-day how a boy did
not scrub well as he
should have and "Mr.
Denz came in my room
and asked me why I didn't

scrub good and as I was
going to explain to him whose
turn it was to scrub he
punched me and I fell
over before I knew it"

now, was that necessary?

Permit me to assure
you that those boys are
not incorrigible unless
they have gotten so since
they have been at Carlisle.

Robert complains of
being slighted with clothes

especially his hat and
wonders why he couldn't
have one like the other
boys. Is there reason
for this?

I understand very well
the circumstances of Carlisle
with its large number
of students they cannot

so for I have been
