Sir— Your letter dated Dec 12-1910 reached me some time ago. now I will answer you. Though I have been to Carlisle School when I was 6 years old with my Aunt Adelia Lowe she is married now. did not finish with my schooling I was sick and stayed at the hospital for a while and after I was doctored I was sent home, I did not remember how long I stayed but I think its a year + half. I stayed at Pine Ridge Oglala Boarding School after it burned down. I went to No 25 Day School. thats the last time I went to school. though I am not healthy and weak eyes. I love to go to school. I am now 29 years old I am not graduate^{nt} any school Will you please sent me the list of the Carlisle pupils and picture of the school my mind is at the Carlisle school yet. Yours. Adelia Lyon.
