Quay met Miss Waggoner at the Carlisle school, and last fall, during a business trip to the west, visited her at her home on the C-7 ranch, near Norristown, S. D. The bride's parents are direct descendants of tribal chieftains, and own 3500 acres of prairie.

Daphne Waggoner, who was a pupil here several years ago, was married recently to Mr. Howard Quay. They will live in Lansdale, Pennsylvania, where Mr Quay is in business.

LANSDALE BUSINESS MAN WEDS INDIAN GIRL

Special Despatch to "The Press."

Norristown, Pa., May 13.—A romance, which had its inception at the Carlisle Indian School and reached to the prairies of South Dakota, had its culmination in a parsonage here to-day, when Miss Daphne Wagonner, a pretty Sioux maiden, became the bride of Howard B. Quay, of Phoenixville and Lansdale.

The bride, who is 19 years old, is a graduate of the school at Carlisle, and it was there last Summer that Mr. Quay, a young business man, met her.

Last Fall while Mr. Quay was making a business trip through the West, he arranged to visit the young Indian girl at her home, the C-7 Ranch near Norristown, S. D. Mr. Quay remained there for a couple weeks and at that time the Indian maiden promised to become the white man's bride.

The bride's parents, descendants of tribal chieftains and owners of 300 acres of rich prairie land, were persuaded to consent.

Miss Wagonner left her Western home alone a few days ago and was met by her fiance this morning, and a short time later were married by Rev. H. E. Bodder in his parsonage.

After a trip of several weeks Mr. and Mrs. Quay will be at home in Lansdale, Pa.



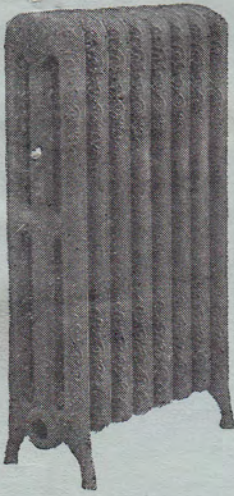

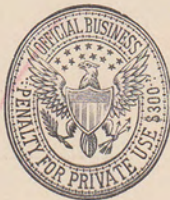

SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.
