# Application for Enrollment in a Nonreservation School.

(For a child not enrolled at an Agency.)

For and in consideration of the United States assuming the care, education, and maintenance in the United States Indian School at Carlisle, Pa., of Cec Locus, Male, I, Cec Locus (Name of child.) (Sex.) (Parent, guardian, or next of kin.) of Wagoner P. O., State of Oklahoma, do hereby voluntarily consent and agree to ~~my~~ enrollment in said school for a period of five years, and also obligate and bind myself to abide by all the rules and regulations for Indian schools. (Not less than 3.)

I further say that the said child was born at Tumsha on Dec. 3, 1891; (Date.) that the father, J. Herman Locus, a full Indian of the Shawnee (Name of father.) (Is or was.) (Degree.) Tribe located at Shawnee Agency; that he left the tribe about 1895; (Approximate date.) that the mother, Julie Locus, was a full Indian of the Shawnee (Name.) (Is or was.) (Degree.) Tribe located at Shawnee Agency, and left the tribe about 1892; (Approximate date.) that the said child was born and reared in the United States, and now actually resides therein; and that he has attended the following schools:

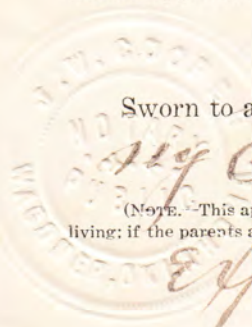

### INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

There is no doubt but what you will be surprised to get a letter from me. But however I will write you and tell you Mr. Oce Locus, getting along since I left that institution some four Braggs, Oklahoma. Been keeping well and hearty, and I have My dear Sir:

I was pleased to receive your interesting letter of the 21st instant and to note therein that you have been actively at work during the entire time since you left Carlisle. It is noted that you claim to have made but little money, but the very fact that you have taken an active part in business and in the life of the community in which you have resided has given you much more than could be measured by mere money. The experiences you have had must have left their impress and you will find more and more that the success with which you may meet is due in a large measure to the accumulation of ideas you gained from time to time and that the smallest incidents may be of most value to you later on.

I trust you will be successful in the new enterprise in which you are now interested and that you will keep us informed here at Carlisle of what you are doing.

Dear Friend:-

There is no doubt but what you will be superised to get a letter from me. But however I will write you and tell you how I have been getting along sence I left that lnstitution seme Four years ago. I have been keeping well and hearty, and I have been liveing up to Carlisle training sence I left the C. I. School.that is, as near as I could.

The first year of my return I went into a Grocery Business. as I was formallis<sup>with</sup> the trade, I made good in the Business that year. And I sold out to a Friend of mine, and he run the Store a while, But he lost all that he had doing credit Business. I then, (The second year.) accepted a position as a Salesmen in a large Department Store in Porum Oklahoma. Four miles from my home. I worked for One year, I saved little Money Then I went to farming on small scales. I made my liveing but I had no luck with Money. Last year I raised Fourty acres of Cotten and Twenty acres of Corn. I made Fifteen Bales of Cotten avageing about Three Eighth of a Bale to the acre. I sold the Cotton thistweek at Seven and One Fourth Cents per Pound. the fifteen Bales brought me \$564.90; my expences was \$286.70 to make the crop. My profit or net clearince for One years labor is \$278.20 You see I did not make much on my Farm. The net earnings with my team was less then a Dollar a day.



This year I will let some one else farm for me, and see if I can do as well renting my farm out.

I am a Clerk and assistance Secretary for THE CHEORKEE MINE AND MINERAL COMPANY. We have a fine speccimen the following Ores. Lead, Assayed, Eighty five per cent to the Ton. Copper, Sixty five per cent. Silver Sixty per cent. Gold, nearly Eighty per cent . and Platinum Seventy five per cent.

We have just started and we have not evry thing in readness . yet to futher the work. We are getting in a position to go to prospecting immediately. However our Company is small with a Capital Stock of \$10,000.00 but we are plenty able to carry on the work. I am not working for salery. I am working <sup>for</sup> One fifth Intrust in the Company. If we have any luck which I am quite sure we will, Ill be all right Fiancially before this time n next year. You see I have all chances to win and not any thing to loose., only my time. You see if any one dont chanceeven his time he will never climb the Hill. This is the first opportunity that I have ever had to climb the Hill. and I have seized the chance.

This is all at this writeing. I only wanted to let the School know ~~how~~ one of her expucils was getting along.
