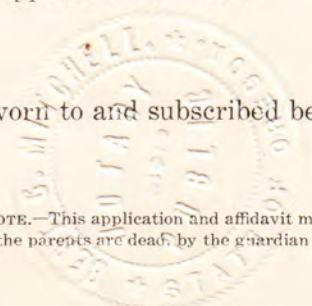

### INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

Dear Sir:- I am writing you again relative to the balance of account of Samuel Tingley, who was a student at your school, but is now deceased.

The mother Mrs. Florence Tingley, residing in this city, informed me that before her son entered the school there was an appointment made of a guardian which she signed the necessary papers to place her son in school.

Of course the mother being the natural guardian I should think there would be no necessity of further action in the matter. Noticed the contents of your letter August 17th, wherein you requested the name of the Superintendent who had jurisdiction of Samuel Tingley before his death, and in reply to this the mother stated that she can not say, only that her son left her control and entered your school.

I wish there was some way of arranging this affairs so the mother could get the benefit of this money. We can send you affidavits from the mother and other setting forth the facts in the case, if this would be necessary.

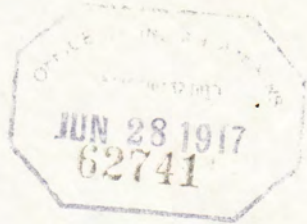

In response you are advised that the funds  
belonging to the decedent now in the possession  
of this school amount to \$10.65. These  
funds are a voluntary deposit and the accrued  
interest thereon. The principal was earned  
by the decedent while employed in the country  
under our Outing system.

The trusteeship exercised by the Government  
over the decedent's property in this case is  
apparently one of fiduciary responsibility  
over the funds of a minor rather than the  
usual trusteeship exercised by the Government.

These funds were not derived from Indian lands  
and no equitable conversion has thrown the  
mantle of the Government's trusteeship over  
them. I am doubtful whether they are trust  
funds in the usual sense.

My dear Mr. Francis:

The receipt of your letter of November 7, 1917, relative to balance of the account of Samuel Tingley, deceased and former pupil of the Carlisle School, is acknowledged.

Upon examination of former correspondence in this case, it does not clearly appear whether or not, the fund constituting this balance is trust property under the control of the Office of Indian Affairs.

Should this be the case a report on heirship, accompanied by the testimony of not less than two persons having knowledge of the facts and showing the heirs of this decedent will be necessary under the practice of this Office before an ascertainment of the distributees to his personal estate can be made.

Please advise as early as practicable as to the source from which the estate of decedent arose, and should it be of the nature over which this Office or the Department of the Interior has jurisdiction, submit report on heirship and accompanying testimony, as above indicated.

Pending receipt of the further information requested, action in the case will be held in abeyance.
