For and in consideration of the United States assuming the care, education, and maintenance in the United States Indian School at Carlisle Pa., of Arthur Oliver Carpenter, male, I, A. Oliver Carpenter (Name of child.) (Sex.) (Parent, guardian, or next of kin.) of Postal P. O., State of N. D. Dak., do hereby voluntarily consent and agree to my enrollment in said school for a period of three years, and also obligate and bind myself to abide by all the rules and regulations for Indian schools. (Not less than 3.)

I further say that the said child was born at Jettle Mts N. D. Dak. on Aug. 21 - 1891; that the father, Joe Carpenter, is a 1/4 Indian of the Free Tribe located at Jettle Mts Agency; that he left the tribe about 1889; that the mother, Emma Carpenter, is a 1/4 Indian of the Shipheaver Tribe located at East Lake Agency, and left the tribe about 1889; that the said child was born and reared in the United States, and now actually resides therein; and that he has attended the following schools:

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

If a fellow gets wanted to go to public school he could not as I did not have any money so I had to get right to work and get some money in order to get some winter clothes so that put me in a bad shape as I want to go to school study. If I had the money I would go to school at Washing D. C. as my brother has asked me to go and stay with him and go to school. I want to go to school very bad but I cannot stay home and go as my father is not rich. If I only had enough money to buy my clothes and books and ect. I could find lots of places to stay
