Sir:

Edward Fox, enrolled at this Agency, attended Carlisle Indian School, Carlisle, Pa., for several years past, there learning the painter's trade. I believe that after he left there he remained in Carlisle for a year or two, working at his trade; that he married a white girl in that town and became somewhat attached to that locality.

Superintendent Lipps advised with me, as well as with Mr. Duntin, my predecessor, stating that Edward was not making it very well in Carlisle. This was evidenced from the fact that he was repeatedly calling for funds at this office. During the year, from January 1, 1914, to December 31, 1914, the following funds were sent to him at Carlisle from this office;

On the advice of Mr. Lipps, because it seemed the best thing to do, this young man was urged to come back here and get on his land and make a living, and home, for himself and family, here. They arrived here this spring in time to

put in a crop, but they have not been satisfied with the place. His land is of poor quality. His wife is homesick for her relatives and friends in Carlisle, and whenever the baby happens to be a little sick they blame it on the Oklahoma climate, -thinking that if it should die it would be because they were here in Oklahoma, rather than back east.

Now, Edward has repeatedly requested me to furnish him money to move back to Carlisle. He has shown me two different letters from his father-in-law, stating that if he was now at Carlisle he could secure work at his trade. On these occasions I have advised Edward that since he is here, and has a crop planted, he better stay with it this year, and gather his crops, and see what he can make, as otherwise he will lose his years work. This, it seems, he has been willing to do, at times, but after going home and talking it over with his wife he has come back again, repeatedly saying he wants to go back east and work at his trade.

This spring the following sums of money were expended for this Indian to start him up at work, and equip his home;

Of course, if he quits the farm here nearly all of the above equipment will have to be sold, -some of it at a sacrifice. In addition to what may be realized from the above this young man has on deposit here \$1415.78. If he goes back to Carlisle to work ^{after} ~~far~~ awhile his work will be less, -when winter comes on, -right now being the busy time of year in his trade.


I have been in doubt as to just how to handle this young fellow's affairs. He is a quite unassuming sort of fellow, seemingly willing to listen to advice. I do not feel that every Indian can be made into a farmer, nor that any Indian should be forced to farm. I believe they should have a chance to do the kind of work they like to do, the same as other people, -as far as possible. It has occurred to me if this young man should go back to Carlisle and make something at his trade, with the money which he has at this office, together with the income from his land which will lease for about \$160.00 a year, this ^{sent} ~~sent~~ to him from time to time, ought to enable him to live in reasonable

comfort in Carlisle, especially if he is able to do anything at all at his trade.

Now, because of their repeated requests in this matter, I am submitting it to the Indian Office, sending a carbon copy of this letter to Superintendent Lipps, who is somewhat acquainted with this young man, and I have informed Edward Fox that I shall be governed in giving him advice by instructions, or suggestions, received from the Indian Office, and by advice from Superintendent Lipps in this connection. It appears to me that the wishes of this young man, and his wife, should be given careful consideration, notwithstanding the fact that he may not be as industrious and energetic as he might be, still he has the same right to live his life as he wishes, and it appears to me should not be altogether forced to follow a line of work in which he is not interested.

Kindly advise me as to the attitude of the Office in this, and similar cases.

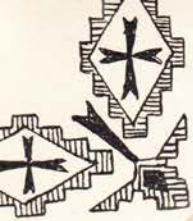

SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case; but in all cases where the parents are living they should first be consulted.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.


