The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case; but in all cases where the parents are living they should first be consulted.



Mr. McKean had charge of the book up to June 23rd, there was no boy carried on ^{present} troop list by that name. I will have to take him up in the morning and report him as a deserter.

I have informed a chief of police here in town to have Edward Lamont arrested, and to keep him there until we send for him. He is to notify us at once, when he has captured him.

My dear Sir:

This is to acknowledge receipt of your letter of January the 7th and to advise that transportation is being ordered placed at Bayfield for the passage to Carlisle of an unlimited number of students. One of the tickets so placed may be used by an escort, but it is usually required that parties of students contain both boys and girls before the necessity for an escort is considered imperative. I will also advise that a party should consist of not less than eight students to justify me in recommending the payment of an escort's expenses to Carlisle and back again to the point from which the party started.

William Butterfly and any other deserters who are now at their homes may be brought back to school, providing, of course, that they pay for all the expenses

that will be incurred in taking the trip.



My dear Sir: A Butterfly deserted from Carlisle Indian School last year, returned to this reservation sometime after he ran away, and after remaining here for a short time he consented to return. He was given a mackinaw by one of our men here. I have noted the request contained in your letter of August the 10th, relative to William Butterfly's desire to be enrolled at the Tomah School, and in reply thereto will state that I shall not object to the enrollment if Superintendent Compton thinks it advisable to give William a chance. The young man has certainly not made a good record at Carlisle, and I believe it would not be worth while to give him another trial here.

The Louis Headley who is alleged to have William's mackinaw is now in a Philadelphia Hospital and cannot be interviewed as is desired. If something definite can be learned later regarding the garment I will write you again.

Some time ago I had a letter from William regarding the trunk he left at Mr. Worth's home, and I advised him to write direct to his former Outing home for it. If he does not succeed in getting the trunk I will assist in locating it.




William Butterfly deserted from Carlisle Indian School last year, returned to this Reservation sometime after he ran away, and after remaining here for a short time he consented to return. He was given a ticket and started on his return to the School. In Ashland he met a number of Odanah Indian boys who persuaded him not to return but go to Minnesota. He returned his ticket to us and on this we secured a refund. He has been in Cass Lake, Minnesota, until about two weeks ago, when he returned here. Do you wish him returned to Carlisle, Pa.? He does not want to go and as he will probably run away again, without an escort, and as it would not pay to send an escort with one boy, I would recommend that you release him if he goes to another school. He expressed his readiness to return, or rather to go to school again, but not to Carlisle. He seems to prefer Tomah, Wis. If you care to release him I will have him signed up for Tomah and if we can secure others to go there will have him sent with an escort.

If you will release William Butterfly, he would like to have some one interview Louis Headley and request him to send his mackinaw (William's Mackinaw) to him, by either express or parcel-post. He would also like to have his trunk sent to him. He stated his trunk is at the farm of Mr. D. Worth, Prospectville, Pa.

Dear Sir:-

I have your letter of the 2nd inst relative to a trunk belonging to William Butterfly, which is now in the hands of William D. Worth, Prospectville, Pa., one of our outing patrons. Mr. Worth, you say, has put in a claim of \$3 against and will not give up the trunk until this amount is paid to him. Mr. Dickey the outing agent, is in the field now and I will write him today to give this matter his attention as soon as practicable. It may be that he can get the trunk and send it to you by express, charges collect.

Usually when a boy runs away from his outing home the patron sends his belongings to the school and the charges prepaid from his wages in the employer's hands. If this is not done right away and the wages are turned into the boy's bank account here and he does not return to the school, we have no way of paying for the return of his belongings. This does not often happen however. I will write you when I hear from Mr. Dickey.

Dear Sir:

I am in receipt of your letter of the 22nd regarding the shipment of William Butterfly's trunk. Would say in reply that on receipt of \$3.00 from Wm. Butterfly I will ship his trunk. Now this may not seem quite right to you, But considering the cost of getting him, the way he left me and the inconvenience he put me to, the storing packing and the delivering 5 1/2 miles to the R.R. station his trunk I feel justified in my charges. On receipt of said amount I will ship his trunk immediately.



I wrote him recently suggesting that he ship the trunk by express collect to this agency in order that the trunk may be turned over to William Butterfly for his use at Pipestone school where he was entered last week as a student.

I am not acquainted with the regulations at Carlisle regarding the return of pupil's property from the outing houses, and I am not therefore complying with the request of Mr. Worth

without receiving instruction from you. If the fee which he has demanded for storage, packing and shipping of the trunk is not contrary to the rules of your outing system, a check will be drawn and William asked to sign it and will then be forwarded to Mr. Worth.

I have your letter of the 2nd inst relative to a trunk belonging to William Butterfly, which is now in the hands of William D. Worth, Prospectville, Pa., one of our outing patrons. Mr. Worth, you say, has put in a claim of \$3 against and will not give up the trunk until this amount is paid to him. Mr. Dickey the outing agent, is in the field now and I will write him today to give this matter his attention as soon as practicable. It may be that he can get the trunk and send it to you by express, charges collect.

Usually when a boy runs away from his outing home the patron sends his belongings to the school and the charges prepaid from his wages in the employer's hands. If this is not done right away and the wages are turned into the boy's bank account here and he does not return to the school, we have no way of paying for the return of his belongings. This does not often happen however. I will write you when I hear from Mr. Dickey.


Dear Mr. Friedman:

The girls referred to in my recent letter should not be sent without a responsible escort, as it is too far for the young girls to make this trip alone, particularly when they have to remain all day at Chicago between trains.


