# NIGHT LETTER

ALL NIGHT LETTER MESSAGES TAKEN BY THIS COMPANY ARE SUBJECT TO THE FOLLOWING TERMS WHICH ARE HEREBY AGREED TO

What is not required to pay for his ticket (\$62.30) and to pay for your expenses as escort to Harrisburg is to be turned over to Paul. It will also be well to notify the Station Master at Harrisburg so that conductors will be instructed to keep the boy on the train and so that there will not be any chance of his remaining in this community.

SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school shall be furnished with the original of this form for his files, and the duplicate shall be deposited in the office of the superintendent in charge of the reservation. The Reservation Superintendent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer. 6-870

## INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

*Provided*, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

That no Indian pupil under the age of fourteen years shall be transported at Government expense to any Indian school beyond the limits of the State or Territory in which the parents of such child reside or of the adjoining State or Territory. (35 Stat. L., 781.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case; but in all cases where the parents are living they should first be consulted.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.

I am in receipt of your letter of the 11th inst. relative to the case of Paul Jones and note what you say as to the advisability of his discontinuing his connection with your school and returning to his home.

All the money to the credit of this young man in my hands at the time was transferred to you October 10, 1912. There are therefore no funds in my possession for the payment of his transportation home. Whether or not his father can advance the money I cannot say, but <sup>I</sup> will take the question up with him at the first opportunity and will advise you as to the result. In my opinion Paul should be retained at the school until the necessary funds can be secured for returning him to his home.

Referring further to the Paul Jones case I have to report that his term of confinement to the Cumberland County Jail will end next week, and as it will not be advisable to have him continue as a student here it is my opinion that he should be sent to his home.

I respectfully submit below a copy of a report that was handed to me by our Disciplinarian on the 11th instant regarding a young man who was enrolled at this school on February the 2nd of 1912:

"Paul Jones who has been a student of Carlisle for some time has been put in the Guard House here on several occasions for breaches of school discipline and has on the whole a bad record while here. By his own admission he was in jail on his own reservation for horse stealing and later for fighting his Superintendent. He said that when he came to Carlisle that his departure was a hurried one in order to get away from the Sheriff at his home who had 24 counts against him for bootlegging whiskey on the Umatilla Reservation."

In view of the fact that he has finally proven himself entirely unworthy of the help that he has been given here and has become so incorrigible that he is a bad influence among the boys who have to associate with
