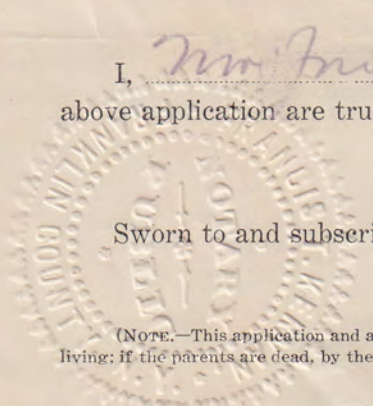

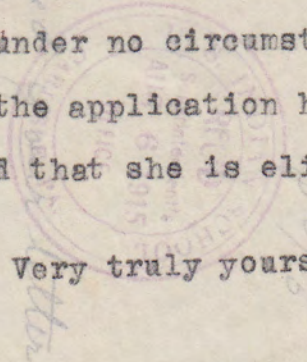

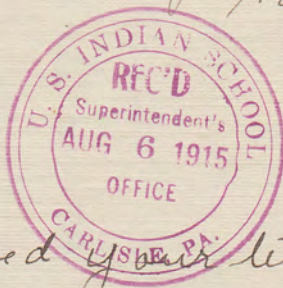

to help him through his occupation..

I have been to Carlisle myself and just now discovering these days that I should have stayed longer, and so I seem to be taking my father's place in trying to educate my brothers and sisters.

My sister has been trying to get to Carlisle for the last two years and he absolutely will not sign his name to any blank in regards to her entering school.

But as we are out here in Vermont, working. I would like to know if we could not just come to Carlisle and leave my sister there. I don't imagine he will remark. after he knows she has worked her own way to school. and I would like to know just what Carlisle can do to help me to transport my sister to school.

We are from the northern part of New York. my sister is eighteen years old and still very anxious to gain all the education that she possible can manage.

Will close with hopes to get some help from the school.

their studies.

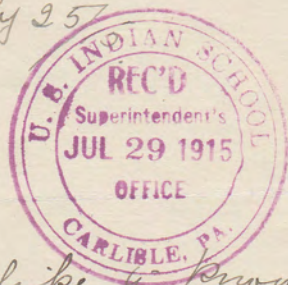
If you desire to come to Carlisle with your sister it
