SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

## INDORSEMENTS.

---

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

*Provided,* That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case; but in all cases where the parents are living they should first be consulted.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.

or as soon thereafter as practicable, for the trial of such persons as may be properly brought before it.

Pursuant to the foregoing order, the court assembled at the place, date and hour therein specified.  
Present the following members:

All Commissioned Officers.

The recorder and accused were also present.

The accused was then given opportunity to introduce counsel, \*but declined to do so.

The order convening the Court was read by the recorder, and the accused was asked if he wished to object to any of the members, to which he replied

\*Counsel must be selected from employes or students of the school only, and if introduced and accepted by the Court, the record should then read: "The court assenting, the counsel appeared and took his seat" and the word "but declined to do so" erased or red lined.

The members of the Court were then severally duly sworn by the Recorder, and the Recorder was duly sworn by the President of the Court, all of which oaths were administered in the presence of the accused.

The accused was thereupon arraigned and tried upon the following charges and specifications:

CHARGE Constantly in town without permission. Associating with women of low and immoral character.

For a long time past practicing fornication with one Hazel Myers a white girl of low character in the city of Carlisle.

Constantly disregarding school rules, and advise and counsel of the school authorities.

SPECIFICATION: In that the said John Bear did on the night of April 20th go to the home of Hazel Myers in company with her and another indian boy, for immoral purposes, and did remain the entire night occupying a bed with her, and having criminal intercourse with her.

That upon being question by the disciplinarian he manifested a cross and mean manner, stating that he was a bad egg (meaning Bear) and that would stick to this girl and his relations with her, and no one could ~~set~~ separate them.

Hazel Myers, the girl, testified that she has been running with Bear for some time, and that it had been their custom to practice adultery many times; and that he had generally ~~had~~ given her a dollar each time. She ~~testifies~~ testifies that he paid her about \$20 in all.

That his conduct and general manner of living is a disgrace to the students of this school as well as the Institution itself.

Hazel Myers testified that for a short time she and Bear did not run together on account of his going with a ~~girl~~ negro girl with whom she saw him on the street, and for whom he bought a new hat, but soon after this she made up with Bear.

To which charge and specification the accused pleaded as follows



I have consulted our agency physician with the view of ascertaining if he thinks the boy is mentally deficient, and on return of his written report, I will, if thought necessary, send him away for examination by a specialist.

I transmit herewith for your information a copy of proceedings of a court-martial that was convened at this school on April the 21st to try John Bear, together with a letter I have just addressed to his mother.

I want to state further that the Hazel Myers with whom Bear associated was found dead on the outskirts of Carlisle several weeks ago and that a coroner's jury pronounced it a case of murder, so that he was not locked up any too soon in our guard-house to escape being mentioned in connection with that case.

Regretting that so unfavorable a report has to be conveyed to you and hoping that there may be some means whereby he can be compelled to make an effort to do better, I am,

In accordance with such authority arrangements are being made to have him leave here this evening. Transportation for his passage to Bayfield will be procured for his use and I would thank you to arrange so that an amount of \$25.12 will be sent to me to pay for the ticket.

It is to be regretted that such information has to be conveyed to you, but because your son would not make use of his time he is not desirable as a student.

His every action here seems to have been directed toward the very worst acts he could possibly become connected with.


