For and in consideration of the United States assuming the care, education, and maintenance in the United States Indian School at Carlisle, Penn., of May Cogswell, Female, I, Joseph Cogswell (Parent, guardian, or next of kin.) of Charlevoix P. O., State of Michigan, do hereby voluntarily consent and agree to her enrollment in said school for a period of three years, and also obligate and bind myself to abide by all the rules and regulations for Indian schools.

I further say that the said child was born at Scottville, Mich. on Jan 28th 1895; that the father, Joseph Cogswell, is a half Indian of the Ottawa Tribe located at Grand River Agency; that he left the tribe about 1883; that the mother, Julia Cogswell, is a full Indian of the Ottawa Tribe located at Grand Haven Agency, and left the tribe about 1883; that the said child was born and reared in the United States, and now actually resides therein; and that he has attended the following schools:

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

When your letter of inquiry about the condition of your daughter Mary's health was received here it was referred to our school physician with a request that he make an examination. I submit below for your information a copy of the statement he issued yesterday:

"Mary Cogswell was in the Hospital from October to December with rheumatism. She is apparently in good health at this time."

In view of this report there seems to be no reason why Mary should not continue with her school work. The satisfactory progress she has made in her studies is a further indication that she is able to go ahead with her school duties and that she has the strength to remain in school.

Regarding her return home for vacation I can only state that the request will have to be given definite consideration nearer the close of this school year. The
