I have noted what you stated in your letter of June the 28th, regarding the return home of Delia Denny to be of assistance in the home of her father. The matter has had careful consideration, but for the reason that Delia's conduct has been such that an improvement in her devotion to her father can hardly be expected it has been decided that she will have to remain here until I am informed by you that there is no other way than to give her a trial at her home.

If Delia is given permission to go home and is then only an added responsibility it is my opinion that it will be better to keep her here. I will be pleased to have a recommendation from you if it is believed best to take any other action than that mentioned above.

Dear Sir:

Your letter of June 16, to Moses Peters, concerning the return of Delia Denny, has been referred to me for reply. The matter was presented to me some days ago, and I then declined to interfere, for the reason that I did not think that Delia would stay at home if she came. She has a step mother, and has not been at home for some years, and just before going to Carlisle was taken to Wittenberg by her sister, Mrs. Palladeau, who reported that she could do nothing with her and asked to send her to Carlisle, where she would be under constant restraint. If Delia is willing to go home and assist in the care of her father it would be very desirable for her to do so, but, as you may infer, I doubt very much if she would remain at home any length of time if she came. I suggest that you talk the matter over with her, and if she is earnestly desirous of helping her father, and will remain with him, I have no objection.

Mr. Denny is suffering with a broken leg, and at present is nearly helpless, and his wife being nearly blind, his condition is serious.
