SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.



## INDORSEMENTS.

---

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

*Provided,* That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form to be used only in transfers from reservations or Indian schools to nonreservation schools.

My dear Sir:

I am returning to you herewith the enclosures you transmitted to me with your letter of April the 13th for Walter Anderson's signature. The deed conveying all of Walter's inherited land as well as his "surplus" to his mother was executed before a Notary Public.

In connection with the return to you of the receipt for an amount of \$500.00, Walter desires me to say that he would like to have at least \$125.00 of that amount for use here. However, it is my opinion that a great deal less than that amount would be sufficient to cover all the expenditures that Walter will incur while he is enrolled here. He is yet anxious to return home for the summer months in spite of the fact that your wishes as well as his mother's regarding the matter have been made known to him.

My dear Mr. Lipps:

Replying to your letter of the 7th inst, requesting what action should be taken with enclosures forwarded by Mrs. Cilla Anderson, to be signed by her son, Walter Anderson, you are respectfully advised this contemplated action by Mrs. Anderson, is the result of a conference had this this office. It has been discovered that since Walter has arrived at the age of majority that his deed to any of his lands, with the exception of his home stead allotment, will absolutely convey fee title, and such deed would not require the approval of any tribunal to complete it's validity. If Walter should once leave the school on account of his past habits and his tendency for drink, he would be an easy prey for any designing persons, and could be induced to sign a deed to all of his land <sup>for</sup> the proverbial mess or pottage. It was, therefore, deemed advisable, as a matter of protection to Walter, that his lands be conveyed to his mother as a check against the contingency as above contemplated.

enclosed with Mrs Anderson's letter describes  
the lands inherited by Walter, it also embraces 120 acres  
of his individual allotment, known as his "surplus", which, he at  
this time can convey. Mrs. Anderson's letter does not explain  
this to him, she probably thinks that it is best to conceal that  
fact, but I think he should know what he has and he should also  
be given to understand it is merely a matter of protection; title  
to this property to be held in trust by his mother and any attempt-  
ed conveyance by her could be repudiated by Walter at any time, but  
I apprehend no such difficulties from Mrs. Anderson as she has the  
best interest of her child at heart. He has been the source of  
great care and sorrow to her and her motherly instinct will prompt  
her to do what is best for him, as is shown by her example in this  
instance.

I, therefore, recommend that it is entirely proper for  
Walter to sign this deed for his interest in these lands to his  
mother, and request that you patiently and carefully explain the  
details of the transaction to him, and urge that it is for his  
best interest to sign the same.

With reference to the receipt for \$500.00, Mrs. Ander-  
son has been to considerable expense, partly in schooling and  
clothing and mostly for indebtedness left behind by Walter, she  
is hard pressed for funds at this time, and as there is some money  
available in his wife's estate, I took the matter up with the County  
Court and asked if an advance could not be made to Mrs. Anderson

The letter conveying this information was handed  
to me by Mrs. Anderson, Walter's mother, this morning. He want-  
ed funds to come home and stated he was staying with a man by  
the name of Daniel Wingard, and this this man would keep he and  
another boy until the 8th. She states that she is of the opinion  
that designing persons, in Oklahoma, have been writing to Walter  
in regard to his property affairs, and probably inducing him to  
run away; she very much desires that he remain in school.

I request, therefore, that a rigid investigation be  
made as to his reasons for deserting, and Mrs. Anderson further

states that she believes it would be to the best interests of Walter to have the Superintendent carefully inspect all mail coming to him, as the Court has recently entered a decree as to some valuable property for him. I would like to have you advise me if these suspicions are correct. If you have not as yet located Walter on receipt of this letter, kindly wire me at once.

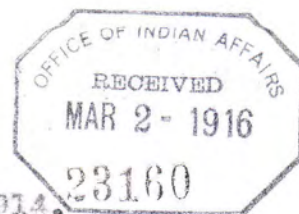

Reporting as was requested by you in your letter of August the 18th, I regret to state that your son Walter has been a deserter twice during the time he has been enrolled here. He was absent from school February 2nd to 18th of this year and again from June 28th to June 29th. No accurate record of his drunkenness has been kept, but as near as it can be determined he has had to be confined to our guard-house ten different times for safe keeping until sobered. He has been drunk twice within two weeks.

Your son David was a deserter with Walter from June 28th to 29th and was also drunk on that trip. He has had a satisfactory record since then, but he had been drunk twice before the dates mentioned.

Trusting that it will be arranged at once by you to take Walter home, I remain,

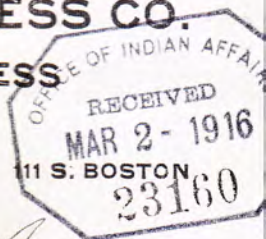

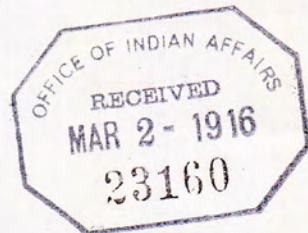

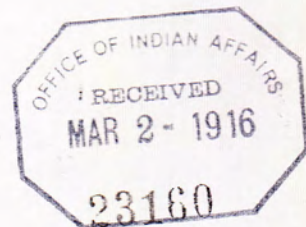

Dear Mr. Kelsey:

In further reference to the telegram that has just been sent to you, copy of which is attached hereto, this is to state that I spent a full hour yesterday talking to Robin Dougherty and Walter Anderson with the idea of assuring them anew that I am anxious to help them settle down to something worth while. The result was that Anderson went to town last evening in his citizen's suit and without permission and Dougherty persists in taking the stand with Josiah Sam that they did not come to Carlisle to learn a trade and that now they are not even willing to obey the rules and regulations that are for the guidance of all the young men enrolled here. I have learned that Dougherty came to Carlisle carrying a six-shooter and it seems that he is now making an attempt to find out just how long his defiant attitude is going to be tolerated. He had made a very good record, however, up to the time the work of this school year began last week.

Huckleberry Sheard is an intelligent looking young man, and as he is a full-blood I decided I would have another talk

with him today. His face is very much in his favor and believing that he may have been influenced by the other young men I appealed to him in my office this morning in the presence of Mr. Roach and our Disciplinarian. An impression was evidently made because he assured me when he left my office at noon that he will let me know before night whether he believes he can do what is required of him as well as all other boys.

You will understand, Mr. Kelsey, that all the young men could be thrown into the guard house and held there until willing to abide by the school rules. That might result in a most unpleasant fight and I believe that nothing at all could be gained by the use of force if they will not see for themselves that they are showing an attitude which cannot result in anything but their dismissal from school.

The indifference shown by the young men is demoralizing and sooner or later other boys will be harmed as well as those of the Five Civilized Tribes who are associating with Anderson, Sam and Dougherty. Since my personal appeals have not been heeded I am of the opinion that nothing can be done for the young men at Carlisle.

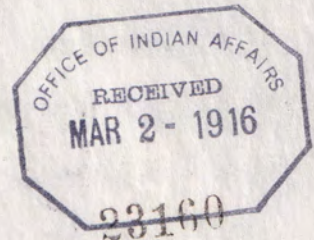

My dear Sir:

This is to report to you that your ward, Beeley Derrisay, was again found in a drunken condition in the Borough of Carlisle one afternoon the latter part of last week and that he is now confined to our School Guard House.

For quite an extended period of time Beeley has not been allowed to draw any money, but in spite of such precautions he has secured intoxicants time and again. I am sure he cannot get intoxicants at any of the saloons in Carlisle, but he is so entirely untrustworthy that he will associate with the lowest type of white or negro to secure liquor. A certain liberty has to be allowed boys at Carlisle and Beeley cannot be kept in the Guard House all the time, so it seems to me that nothing less than a body guard in constant attendance can keep Beeley away from liquor. Furthermore, this is not an institution where cases like his are expected to be handled. It is the purpose of this school to give an opportunity to those students who can reasonably be expected to make some progress and no time at all to fellows who are apparently worthless and a menace.

Your ward has done practically nothing along vocational lines and his knowledge of English seems to be confined to a choice lot of profanity. Even that he will not use unless he is drunk. In view of all the young man's shortcomings I have decided that nothing at all can be done for him at Carlisle.

This is to notify you, therefore, that Beeley must be taken away from Carlisle without delay and that he will be kept under punishment until I hear how I shall co-operate with you to remove him to some other institution or to have him sent to your home.

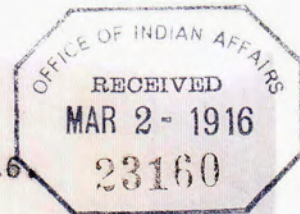

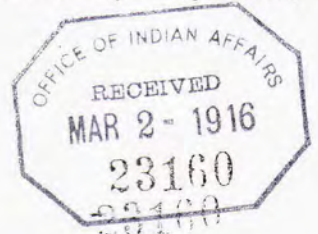

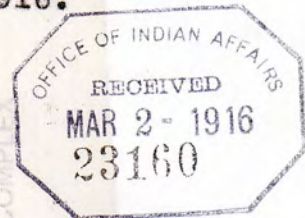

My dear Mr. Parker:

This is to acknowledge receipt of Acting Superintendent Strain's letter of the 28th ultimo regarding an inquiry by Robin Dougherty's guardian why a part of the amount that was deposited for Robin's tuition should not be refunded and to report that during the second quarter of the fiscal year 1914 the entire amount received for tuition was deposited in the Treasury of the United States. It is not known whether favorable consideration would now be given the request to have a refund made, but I will gladly cooperate as may be suggested if a claim for a part of the \$167.00 paid is to be presented to the Treasurer.

The charge of \$98.70 now outstanding against Robin and the three others who had to be removed from Carlisle with him is a proper one and I trust prompt settlement can be made. Your further assistance in the matter will be appreciated.



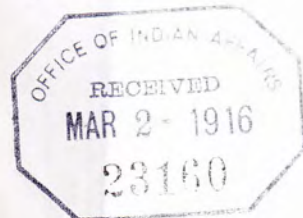

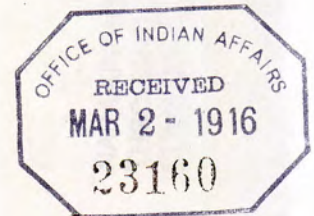

Dear Mr. Lipps:

Mr. R.B. Hutchinson, of Checotah, Oklahoma, the guardian of Beeley Deerisaw, a fullblood Creej Indian boy who is now about 19 years of age, came to see me recently concerning the enrollment of his ward in the Indian school at Lawrence, Kansas. This boy was formerly enrolled at Carlisle where, I am informed, he remained for about one year and later was enrolled at a school at Lebanon, Tennessee. He returned home in November of last year and has not been in school since that date.

I find in our correspondence here a copy of a letter you wrote to Mr. Hutchinson in August 1914, advising him that Beeley was again found in a drunken condition and that he was confined in the school guardhouse. You requested that the guardian make provision for the education of this boy in some other institution. Mr. Hutchinson now represents that Beeley has reformed to some extent and that he has not been under the influence of liquor lately. He also states that

the boy is very anxious to go to Haskell and that he apprehends he will not remain in a school where only white pupils are enrolled. I would thank you to write me fully concerning this boy and whether or not you think it advisable to request the Office for authority to enroll him at Haskell. I earnestly desire to do the very best thing possible for the boy but I am not sure that his conduct would be much better at Haskell than it was at Carlisle.

Receipt is acknowledged of your letter of the 2d instant, relative to tuition paid for Robin Daugherty, Josiah Sam, Beeley Derrisaw and Walter Anderson. You state that the entire amount received for tuition was deposited in the Treasury of the United States, and you are unable to advise whether favorable consideration would now be given a request to refund a part of said tuition.

The office would like to be advised whether or not it is customary, under your rules and regulations, to refund any part of the tuition where it is requested that the student be transferred to another school, or removed before the end of the term, on account of misbehavior of said student. If it can be done, under your rules and regulations, it is believed that a claim should be made for the unearned portion of the tuition paid, especially by Robin Daugherty.

Since the money was deposited in the Treasury by your office, it is also believed that a claim therefor should be presented by your office. If, however, these boys

were enrolled in your school with the understanding that no tuition is refunded, and you will write this office a letter to that effect that can be presented to the guardian of Robin Daugherty, the guardian will, no doubt, pay his part of this bill.

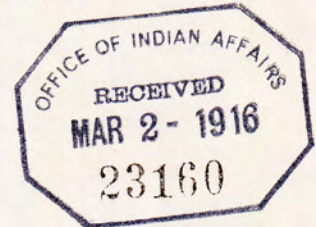

The report of the Disciplinarian at school as to your behavior is not very good and stands in the way of you receiving favorable consideration upon your request. It appears that you have not behaved the best and have given the authorities some trouble. Inasmuch as it is my duty to cooperate with the Superintendent, I must, therefore, deny your request to leave the school until you have earned this privilege by your good behavior. Your mother also very much regrets this but feels that you should stay at the school until you have merited, by your actions, the right to such privileges.

Replying to your letter of October 22, 1913, enclosing certain papers transmitted from Superintendent Friedman of Carlisle, which had been presented to him for signing by Walter Anderson, a student there, and requesting that I make report in the matter, returning all papers, you are respectfully advised the power of attorney was for the appointment of Cilla Anderson, who is the mother of Walter Anderson, the purpose of the power was to give Mrs. Anderson the proper authority to look after her son's interests and see after the proper renting of the land, collection of rents, etc.

I did not deem it necessary, however, to give her the power to grant, bargain, sell or otherwise dispose of any of his land, and upon objection by this office, she consented that that portion be stricken out. I have, therefore, had a new instrument drawn, which gives her the power to look after the interest of her son, without having the power to sell any part or otherwise dispose of it.

This I believe is for the best interest of Walter because  
some one should look after his property while away and I re-  
commend that Walter be permitted to sign said power of attorney.

On the 6th instant I wrote to Walter Anderson, a student of your school and enclosed an oil and gas mining lease drawn in my favor from Mr. Anderson together with a letter from his mother asking him to sign the same. I also enclosed New York draft to his order for \$20.00 as she stated that he had written her for that amount. The Probate Court records of Tulsa County, Oklahoma, show Walter Anderson to be of age and at the time I took the first oil and gas lease from him we presumed that he was of age but the Rolls to the Five Civilized Tribes do not show him to be of age, therefore, we are drawing a new lease and he was instructed by me and his Mother to take the matter up with you and you could explain it all to him very easily and he could execute and acknowledge the lease before you.

I would appreciate it very much if you will attend to having the same executed and gladly remit whatever expense is incurred in connection therewith, upon having you advice as to the amount, and I wish at the time of execution of the same you would fill out and forward the notice to the Department at Muskogee that the lease has been taken, which notice is required to be placed in the United States mails within 24-hours after the execution of the lease.

I can have Mr. Kelsey at Muskogee write you in full if this is not sufficient explanation.

Sir:

I am enclosing herewith draft payable to Walter Anderson for \$20.00. I am also enclosing a letter recently received from him, for your information. In this letter he complains that his mother is not giving him any money. It is his mother's wish that he have all the money that he needs, providing, it meets with your full approval. In the letter he states he desires to take a trip to Niagra Falls and some near by points, this money is set<sup>N</sup> for that purpose, but is to be supervised by you. If his actions have been such that he is entitled to take these trips the matter is to be left entirely to your discretion, as Mrs. Anderson wants her son to follow the rules of the school strictly and be taught the discipline that he still sorely needs if he is to be given any credit for his efforts. I will be glad to hear from you as to Walter's behavior and any favorable indication that I can give to his mother will be greatly appreciated. She seems to worry about Walter a great deal.

Your telegram of the 22nd asking recommendation for the return home of David Bruner Anderson received. The influences and environments are bad. Mrs. Anderson's husband is given to drink very much and his associates are the same. Mrs. Anderson herself admits that it would not be best for either one of her boys to come home, and having the interest of the boys at heart, a feeling that great ~~peace~~ peace of mind will be given to Mrs. Anderson by insisting on their remaining at school, I cannot recommend that David or Walter be permitted to return home.
