I further say that the said child was born at Hogansturg on 1893; that the father, Paul Swamp dead a 3/4 Indian of the St Regis Tribe located at St Regis Agency; that he left the tribe about never left the tribe; that the mother, Matilda Swamp dead a 3/4 Indian of the St Regis Tribe located at St Regis Agency, and left the tribe about never left the tribe; that the said child was born and reared in the United States, and now actually resides therein; and that he has attended the following schools:

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

Dear Sir

The writer of this letter took Margaret-Swamp from your school about five yrs. ago, after her time was up with ^{Carlisle} you will recall I took her under my personal care.

With a very watchful eye every thing has passed pleasantly until lately, some people here have told me Margaret has been meeting boys on the outside when I thought she was at church or visiting a girl companion.

My husband has Western interest and has been away for six weeks prior to his going he told Margaret if she did not do better we would send her to her home in New York State, she said she would not go as she was 21 and would do what she pleased.

Last August a woman opened a candy store here her husband works in Phila, her home is in the next town five miles distant, I feel she is responsible for all of my trouble, she has put some awful notions in Margaret's head & it is at her place so my friends tell me Margaret meets the boys, well to shorten a long story, Margaret left here yesterday to live at this woman's home & do

her housework while she comes here to run the candy store, Margaret boasted now she was free she could have boys visit - her take her to cheap theatres dances & also that now she could go to Phila. alone. If you will consult Miss Johnston or any of the teachers at Carlisle who will remember Margaret Swamp they will tell you she is mentally deficient she was instructed at Carlisle, I sent her to school here two winters, nevertheless she cannot tell the time, count money in fact I could never send her to the store without a note if I needed more than one article, the Collingswood teacher told me she had a body of a woman on the brain of a child of five.

Now what I desire to know is where my responsibility, ^{rests} I could never have her in my home again but I would like some influence brought to bear to send her to her brother and sister who live at Hogansburg New York.

To shield herself she will lie something awful & owing to her mental deficiency she does not know the nature of an oath.

In this new home she is alone from 7.30 A.M. to 8 P.M. weeknights - Saturday nights until midnight - as I said before while the woman

attends the store here & her husband works in Phila & knowing her weakness she would be an easy prey to anyone who might come along. She boasted to me she intended going to Phila. every Sat night she might fall a prey to white-slavers as every man who notices her is nice.

While I took her to the city out in auto to the seashore amusements &c, knowing her mental weakness I could not trust her alone.

Please advise me what to do, don't you think best to send her to her people in Hogsansburg N.Y. I opened a bank acct. for her & I will hold the book until I hear from you. Force will have to be used as she says she will not go and this is where I appeal to you please give this your earnest attention & act quickly.

I have your letter of the 16th inst. saying that when you left Mrs. Kunkel's home she refused to let you have your money and your mother's will.

When you were given permission to live with Mrs. Kunkel, and not be under the jurisdiction of the school, we relinquished our authority over you. This was done in accordance with your wish and also Mrs. Kunkel's. You have taken matters into your own hand by leaving this home without consulting the Carlisle school, and I do not see what we could do to help you to get your money. This trouble is between you and Mrs. Kunkel and no one can settle it but yourselves.

Mr. Kunkle's home is a beautiful home at West Collingswood, N. J. about four miles from Camden. A greater part of the week the family consists of Mrs. Kunkle and her mother as Mr. Kunkle and son are traveling salesmen. As the work is very light. The atmosphere of the home seems to be a very happy one. Mrs. Kunkle would like to keep Maggie for the winter and Maggie would like to stay. I think it would be a very fine home for her. She will attend school probably more than 100 days beginning ⁱⁿ Sept. Mrs. Kunkle and Maggie are very happy with each other and Mrs. Kunkle helps Maggie in sewing.

Maggie's winter coat is very shabby. I examined it and think she ought to have one sent her for Sunday. The size is 36, also she ought to have enough goods for a school waist - blue serge. Mrs. Kunkle will assist her to make it.

When at Carlus Maggie had repeated attacks of appendicitis. Since being out in the country she has been quite well. Miss Gaither told Mrs. Kunkle if Maggie developed any serious trouble to send her to a hospital in Phila. Miss Gaither named the hospital. I was unable to tell Mrs. Kunkle which hospital Miss Gaither had mentioned. Mrs. Kunkle would like to know which hospital is preferred by Mr. Friedman
