SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

In answer to your letter of August 12th, 1914, in which you quote letter from Mr. Charles Bishop of Beaulieu, Minnesota, relative to permitting his daughter, Ernestine Bishop, to come home, I have to advise that Ernestine Bishop was enrolled in your school for a period of one year, that she paid her own traveling expenses to the school, and that it was the understanding that she should return to her home at the close of the year if she so desired. I think your enrollment blank will show this to be true. It is my understanding that she has plenty of money on deposit under your jurisdiction to pay all her expenses home. I have to recommend therefore, that the request of her father be complied with.


I am herewith returning check # 23987, dated Sept. 16, 1914, drawn against the account of Ernestine Bishop in the sum of \$615.88, which you forwarded to this agency recently for the purpose of having Ernestine Bishop sign the check and having the funds transferred to this agency. This girl refuses to sign the check stating that the money was voluntarily placed to her credit with you at the time she entered school and that *she is entitled to the money. Under the circumstances* I am unable to take this money up on my cash accounts.

In this connection your attention is called to Par. #16 of Regulations for Handling Individual Indian Money, which gives you the authority to both sign and approve the check transferring funds of this kind to other superintendencies.

Your attention is also called to Sec. 11a of the Regulations for Handling Individual Indian Money, which authorizes the payment of funds voluntarily placed in the hands of a disbursing officer, direct to the depositor, provided he is an adult.

You may use your choice as to which authority you wish to use. Probably you will not wish to use either.



My Friend,

I have your letter of the 28th, relative to your money on deposit here and in reply have to advise you that you have \$615.88 to your credit, this includes all you have on deposit, a balance of 641.49 left from the 700.00 deposited together with your country wages, 13.73 and interest on the account 10.66 making in all 665.88 less the 50.00 you drew when you left for home.

I could not send a sum like this to you direct. The rules governing individual money require that it be transferred to your agent who will consider any request you have to make. I would suggest that you call on Mr. Howard who will explain to you fully the rules, and disburse any reasonable sum that you may need.
