My dear Sir:

I regret very much to inform you that Silas Brave Eagle was returned to Carlisle in an intoxicated condition on Thursday night of this week, after he had gone away with other boys from this school to represent Carlisle in a football game. In view of the fact that Silas had been selected with other boys to represent the school his deliberate misconduct is inexcusable and it has been decided that he cannot be kept here in school. Accordingly arrangements have already been completed to have him leave here this evening. Transportation for his passage to Interior, South Dakota, will be provided for his use and just as soon as it is determined what the transportation is to cost I will ask you to co-operate with me in collecting the amount as well as an additional amount of \$2.00 that was advanced Silas this morning to pay for incidental expenses enroute home.
