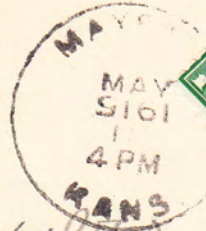

The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.



My dear Sir:

I return to you herewith the duplicate of the application you forwarded to me with your letter of November the 20th to cover the transfer to Carlisle of John Mcough-gee. His physical condition seems to be satisfactory and it has been so noted by our school physician on the copy I am returning to you.

It is to be regretted that the boy was sent to Carlisle without all the facts in the case being known to you, but now that he has been enrolled he will be given every chance to make good use of his time and a better record than that reported by you.

The information contained in your letter indicates that John has funds to his credit with you, and that being the case it is my opinion that there should not be any objection to his being charged with his transportation to Carlisle. In view of his past record he should have contributed in some way toward getting started and paying

Dear Sir:-

In compliance with your request of November 16th, I have completed the application of John Meough-gee, so far as I have been able to do so. The records of this office are not complete and having been here only since September of this year, I am not very well acquainted. It is thought this boy attended the Potawatomi Boarding school until it burned down in 1910. In the fall of 1913 he enrolled with the Phoenix school and deserted from that school in a few months after. I did not know until today he had deserted but was under the impression that he had refused to return for the balance of his term after being home for vacation.

This boy appeared to be in earnest and believing he was acting in good faith and since he agreed to pay his own transportation to Carlisle if necessary, I felt like he should be given a chance. He is old enough now to know what he should do, but if for any reason he proves an undesirable, I will send his return transportation from his individual funds. If on the other hand, he takes an interest in school, I believe he should be reimbursed for his transportation.

This agency has no Physician and therefore it has not been customary for us to fill out the Physician's certificate on the application form.





The boy is rich in land, his income being about \$1200.00 from lease rentals, and I will try to induce him to spend a part of the summer and next winter in a sanitarium or a private home where he may be supplied with proper food and have the benefit of the open air.

Mr. Meyer:

John Meoghee, who is tubercular, should be disposed of by sending him away. He is in good general condition but as he is actually passing the germ in his sputum I consider it advisable to send him off for sanitorium treatment. I wish here to call attention to the fact that we can probably solicit the aid of the State tuberculosis sanitorium situated at Mt. Alto for those patients, such as Alice Logan, who have no proper home to go to.

Elsie Jones is at present under my care with every indication of active tuberculosis. I will report in regard to her case at a some future time.

There are a number of children at present who are showing signs of tubercular infection. These have been under active observation, but as none show signs of active disease, I will retain them at school keeping them under medical surveillance.
