SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.

When the contents of your letter of the 25rd instant were brought to the attention of Victor Dolan, he requested me to write you again relative to his desire to engage in some useful employment after he returns to his home. He stated that when he was at his home in 1910 he was unable to find anything to do, and that he should like to have something definite in view before he leaves here, either the assurance that he can go to work on his own land or at some work other than farm work. Victor fears that if he does not return home until after the close of this school year he will have very little chance to make a success of his farm work even if he can have the use of his land.



I am in receipt of your letter of March 30th, relative to Victor Dolan.


The situation with reference to Victor's farm land is this: This reservation has not been allotted, the farming tracts used by the Indians being informal assignments only, to which they have no actual title. The tract which Victor claims was formerly used by Blanco, his grandfather. Before the old man died, he expressed a wish that the land be turned over to his grandson; and, in accordance with this desire, it has been reserved for Victor. Victor has never used the land in question, as he has been in school since he became old enough to work; but it has been kept in cultivation as it was not desirable that the place lie idle until Victor was ready to take it over. It was farmed for three years by Juan Via, a son of Blanco's wife, and, for the past two years, it

has been used by Julio Mendez, another Indian of the same band. No rental was asked for or collected. The tract embraces approximately 22 acres, nine of which were broken this year and planted by the man who did the work. This man is to receive the entire crop as pay for his services. The other thirteen acres will be planted as heretofore, provided someone can be found to undertake the work. If Victor desires to return and farm it himself, he should act immediately, as the planting season is at hand. This tract of thirteen acres should yield approximately 20,800 pounds of oats, which, at \$1.50 per cwt., (the usual selling price) would bring in a revenue of \$312.00.

I am thoroughly in sympathy with Victor in his desire to engage in some useful and remunerative employment after he leaves school, and I sincerely trust that he will continue strong and earnest in this wish. He may be assured that he will receive all possible assistance from this office. Of course I do not know his qualifications, but if he will have to depend upon his knowledge of engineering for a livelihood he must expect to go to some place distant from the reservation for employment, as there is but little opportunity for him to obtain work of this character nearby. The only possible hope I can hold out to him at present is the possibility that a vacancy will occur in the position of Laborer at this school.

This position pays \$40 a month and is filled at present by a Mescalero boy whose services are satisfactory. The principal duties devolving upon the incumbent consist of assisting with the firing of four low-pressure boilers and the running of the school steam laundry plant. If the present incumbent should quit, I would be very glad to give Victor a try at it. The only other positions here which might become available are two thirty-dollar-a-month laborer's jobs, which are filled at present, but which may become vacant at any time. The Indians in these two positions are employed in general work around the place - assisting in the care of the livestock and the barns, helping with the issues, acting as interpreter at the office, etc. I regret that I can give Victor no definite assurance of employment at the agency.



SUGGESTIONS FOR SUPPLYING THE INFORMATION REQUESTED ON THIS BLANK

1. The report of nonreservation school Superintendent should be made at the time or a little before the pupil leaves school, whether at the end of the school year or during the school year, provided the pupil is 18 years of age or over, or younger, if for any special reason the pupil is quitting school permanently. As soon as this report is received, or at least very soon after the pupil returns home, the Supervisor of Indian Employment will correspond with the returned student for the purpose of getting more in personal touch with him and finding out something about his wishes, etc. His answer will be attached to and filed as part of this report.

2. Health, height, and weight of returned students are sometimes very important in placing them properly; height and weight could be approximated very satisfactorily, though from the pupil records now in use all information called for in part 1 of this blank can readily be obtained and be definite.

3. The State, agency, and tribe are important, and where the pupil is not attached to any agency this fact should be stated and the Superintendent should give all available information as to the home and local conditions surrounding the pupil.

4. Where the outgoing pupil has passed the civil-service examination for any position, this fact should always be noted, giving position for which examination was taken.

5. It should be remembered that the Supervisor of Indian Employment can but seldom have a personal acquaintance with the outgoing student, and that he must depend on the information furnished in this report for his basis of action in behalf of the pupil.

6. The degree of Indian blood should always be given, as this fact largely determines how much effort will be made on behalf of any particular returned student; qualifications being equal, or nearly so, the preference will be given to those having the greatest degree of Indian blood.

7. This report should be forwarded promptly to the Supervisor of Indian Employment, Indian Office, Washington, D. C.

8. Reports on students from reservation schools should be made only as to those who leave the schools at 18 years of age, or older, and who will probably not go away to school.

9. If part 1 of this report is made out by the principal of a reservation school, the reservation Superintendent should supply information called for in part 2 if the principal is not informed as to home surroundings and local conditions. Such information is essential to a proper understanding of the difficulties and needs of the pupil.

10. When part 1 is made out by a nonreservation Superintendent, this blank will be sent by the Supervisor of Indian Employment to the Superintendent of the reservation where the outgoing student belongs. He should fill out part 2 and return the blank as promptly as possible, for practically nothing can be done until the information called for in part 2 is supplied.

Information under the heading "Employed since return as follows," will be valuable only in cases where the pupil has been home for some time.
