My dear Mr. Lipps:

George Finn came here on Saturday last, arriving
at 4:30 yesterday afternoon. I received your telegram to have him
receive him. We have arranged the program to have the following sub-

ability, we shall be glad to promote him to a higher class than the
4 Preparatory Division in which he is now classified. I do not
say that I like the plan you've suggested and his career, and I be-
lieve he will do good work. I want a direct letter from you stating
that he will work with you. He has \$10.00 in his pocket, but it seems to me
that he had almost no money to buy books, so that he had your letter
account, an advance tuition and boarding, and had \$10.00 for pocket
spending purposes, for typing materials, supplies, etc. If you think
we ought to ask him for the \$10.00 we shall be willing to do so.

We have placed him in a room with another boy, but George came
to us a few minutes ago and asked to be placed in a room alone, intimat-
ing that there is another young man at your school who is thinking of
coming to this school. I shall be glad to give you information concerning
the progress of George from time to time.

George Pike came here on schedule time, arriving at 4:30 yesterday afternoon. I received your telegram in good time to receive him. We have arranged his program to have the following subjects: Arithmetic, Grammar and Composition, History, Geography, Penmanship, Typewriting and Shorthand. I have followed his suggestions and trust that it will be a satisfactory program. If he shows good ability, we shall be glad to promote him to a higher class than the A Preparatory division in which he is now classified. I am frank to say that I like the young man's appearance and his manner, and I believe he will do good work. I think a former letter from you stated that he will come with \$40. He had \$40 in bills, but it seemed to me that he had almost no other money beside, so that he has paid \$35 on account, as advance tuition and boarding, and kept the \$5 for general spending purposes, for buying stationery, supplies, etc. If you think we ought to ask him for the \$5, we shall be willing to do so.

We have placed him in a room with another boy, but George came to me a few minutes ago and asked to be placed in a room alone, intimating that there is another young man at your school who is thinking of coming to this school. I shall be glad to keep you informed concerning the progress of George from time to time.
