INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

VACATION REQUEST FOR PUPIL. 36

I, the undersigned, respectfully request that leave of absence be granted to my
daughter Madella Anderson
 from Carlisle Pa to Tuscarora Reservation to
 enable her to visit our home. We hereby agree to pay all expenses, including
 round-trip railroad fares, sleeping-car fares, meals, lodging, stage fares, telegraph and telephone messages,
 and other incidental expenses connected with the visit. We further agree that said pupil shall be
 returned to the _____ school on or before the last day of the leave of absence.
 We further agree to deposit with the superintendent of the school sufficient money to defray all expenses
 to be incurred, and should the pupils, or any one of them, fail to return to school at such time as may
 be agreed upon by the parents or guardian and the superintendent of the school in which the pupils
 are enrolled, the amount of money remaining with the superintendent, necessary to the return trans-
 portation of the pupil or pupils so neglecting to return, shall be forfeited to the Government; provided,
 however, that in all cases where it can be shown that there were justifiable reasons for the failure of the
 return of the pupil the forfeiture of the funds shall not take place.

If the pupil neglecting to return is from a reservation, the superintendent of the reservation shall
 certify to the reasons for the nonreturn of the pupil or pupils. If a pupil's home is not on a reservation,
 then the certificate of some reputable, disinterested citizen of the community may be requested as to
 the reasons for the nonreturn of the pupil or pupils.



My dear Sir:

This is to acknowledge receipt of your favor of the 22nd instant and to state that in my letter of September 17th, 1915, it was reported to you that Madella Anderson has an amount of \$17.92 to her credit over and above the amount of \$8.85 I shall be compelled to confiscate to the Government if satisfactory evidence of good and sufficient reason for the failure of the mother to return the girl to Carlisle cannot be given.

Of the amount of \$33.92 to the girl's credit on June the 4th she drew \$16.00, which left the \$17.92 yet here. To the amount of \$8.50 that was deposited from the money that was sent here by the mother Madella added an amount of \$8.50 that evidently came from the total of \$16.00 she drew before she left here. The cost of her ticket home, \$8.15, had to be paid from the total of \$17.00 deposited and there is yet left the \$8.85 that has been mentioned in other correspondence.

Dear Sir:

I have had some correspondence with the United States Indian School relative to certain moneys due Madella Anderson, a Tuscarora Indian of New York, whose mother's name is Elvira Anderson. They are now residing on the Tuscarora reservation. I am informed that the girl was under the outing system at Carlisle and while there earned \$33.92; that her mother applied for leave of absence for her and sent to the School \$8.75 to pay her return fare, which would make to the credit of Madella the sum of \$42.67, \$8.15 of which was used in paying her transportation home and it is claimed on the part of the School that Madella was permitted to draw \$16.00 of her money at the time of leaving. She denies that she received the proceeds of this check. Even if she did, it would seem from the statement of these people that she should have to her credit \$18.52, instead of \$8.85, as claimed by the school. The reason that Madella did not return to the School at the termination of her leave, I am informed, was because she contracted sore eyes while at work in the outing system and the physician near the reservation advised her

mother that it would be best for her not to return to School on account of the condition of her eyes.

I wish you would write me again relative to this matter, and a little more fully, for if Madella had \$33.92 to her credit that she earned while in the outing system and her mother sent \$8.75 by post office money order, she should have to her credit more than what is stated in a letter which I received under date of September 17, 1915. These people have been so insistent in regard to this matter that I feel that I ought to clear it up for them if it is possible.

But \$8.15 was required to pay for the ticket she used in going home and there is yet to her credit the balance of \$8.85 which is to be used to pay for transportation that will be provided as soon as the mother states that she will comply with her agreement to let Madella return to school to complete her period of enrolment.

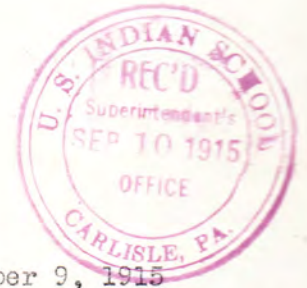



NOTE.—One of these blanks should be filled out by each pupil at Government boarding schools, preferably with the assistance of the superintendent or some one designated to act as his representative. If the superintendent is of opinion from the information given that the pupil is entitled to enrollment he should so indicate by signing the blank in the proper place and filing in the individual pupil's folder. In the case of pupils concerning whose eligibility or need of Government aid there is some doubt, superintendents should make proper remarks and recommendations in the space indicated and forward the form to the Indian Office for consideration.
