INDORSEMENTS.

And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

That no Indian pupil under the age of fourteen years shall be transported at Government expense to any Indian school beyond the limits of the State or Territory in which the parents of such child reside or of the adjoining State or Territory. (35 Stat. L., 781.)

The rules provide that—



No doubt you have seen in this month's issues of the ARROW the sincerity of my attempts to lay a renewed foundation at Carlisle by enrolling only those students who can be highly recommended. While Elsie was not one of them she associated too constantly with several who were unruly and finally she was almost as indifferent as they were.

My dear Mr Lipps:

Your communication of the 2nd came to hand and contents carefully noted.

In reply will say that I am very sorry to learn of my daughters character. I have constantly written to her and tried to convey the idea that she must make good use of her time while at Carlisle and learn all she could and it grieves me to think that she has never heeded my advice.

It was my object in sending her to Carlisle to gain an experience of good discipline, such as I had, but during my short visit last March, I was convinced beyond a doubt that the school was greatly disorganized and almost without any discipline; I feel then that my daughter was permitted to indulge in things, that was absolutely against my wishes. I feel that Mr Friedman was rather loose with the students and allowed things to be carried on, contrary to the object of the school.

I cannot hardly concur, in holding students responsible for such , when the head of the Institution permit it.

It seems to me, that the Indian Office and the faculties of the school should be more determined to enforce more rigid regulations; (show no special privileges to none) in order to attain the standard desired rather, ,than to turn a good shoulder to a child and to encourage them rather than to discourage

I further feel that if Elsie is not good enough to return and pursue her school work at Carlisle ; she is not good enough to enter no other school and I consider it, as the

for honorable existence in this world.

Carlisle should not turn its cold shoulder when she happens to start on her wrong foot at the beginning of her term.

I have again given my daughter a good talk in regard to this matter and she has assured me that she will use every effort to make better use of her time than she did in the past, and that she that she had already made up her mind, before she left Carlisle in June; that she was actuated by your talk to the students before they left for their homes and my talk to her the other day will impress upon her mind the necessity of having a worthy purpose then strive to realize it in full.

Hoping every effort will be used to encourage her and use the discipline to accomplish the schools purpose. I note however , that she has learned things she would not have , had ^{she} stayed here, and I can see considerable change in her.

My best wishes is always with Carlisle , although I do not make any more noise than some others. My deepest feeling is always with the school, because, the biggest part of my life was spent there; coming there in June of 1882 without a knowledge of English Language and in 1891 received my Diploma.

My dear Mr. Kohpay:

When your favor of recent date was referred to our School Matron with a request that she report definitely how your daughter Elsie conducted herself during the school year a reply as follows was submitted:

"In answer to your request regarding Elsie Kohpay's conduct the past year, I have to say from my viewpoint it was not altogether satisfactory, although there has been such a marked improvement over what it was when she left here last summer that I feel if Elsie was firmly but kindly disciplined and very carefully guided she will come out all right. The evening before she left she asked to have a private talk with me in which she expressed great appreciation for what I had done for her and that she would do her best at all times to be the best girl she could make of herself. She seemed very earnest and I feel she will do well.

Hoping this will be what you ask regarding the above, I am,"

I am pleased to report that Elsie did make a better record this year than last, and as she is just getting to the age where she can be expected to forget some of her more careless girlish ways I trust you too will find her an improved girl in so far as her conduct is concerned.

Our records show that during the year Elsie expended a little more than \$75.00, except she received money direct of which no official record could be kept at this office. When she returned to Carlisle last fall she had to her credit in bank an amount of \$16.78. On November 10th and December 26th amounts of \$30.00 and \$10.00, respectively, were received from you for her use. On February the 10th of this year the balance of \$19.05 that was not required to pay for her transportation last summer was placed to her credit and was allowed her for personal expenses. There were also credited to her account during the year two small items of interest, but in amounts less than one dollar each.
