Dear Mr. Lipps:

I received your kind invitation of coming in for commencement week. I thank you very much but I will think this over. It does not cost so little to go there although I am very anxious to see you. I remember you and your little daughter Lucil very well but slightly remember Mrs Lipps. I use to clean your office at White Earth, every Saturday morning.

I remember when you were leaving for Chilocca my

sister went with your party of students you took with you I cried because I could not go unkind of my eyes being sore.

I still have that trouble and all last winter I did not go to school, I was there at Carlisle. And so it is this winter but I manage to go this far. I find on Sunday's they feel better than any other day. Before I came out last fall I got a pair of glasses I wear them but still I have a headache especially over my right eye.

I don't think I can stand it much longer so I am asking you if I could stop

My eyes get so inflamed
at times and leave spots Dr.
Fralic use to call them ulcers
he was afraid to let me come
out unkind of my eyes.

I am tired of complaining
about my head aches and
Miss Butler thinks my eyes
need rest so she never
lets me read on Friday
evening after school and
Saturday. They are very
careful about me.

Other wise I am in perfect
health. My hundred days of
going to school will be up last
of this month. I don't think
I can stand it till then.

I would like to come in
more to see you than any

thing else but it is too
bad I am so far from
Carlisle. How I wish you
were to be our superintendent
for all the time.

My dear Frances:

I was very much pleased to receive your letter of March 8th. It is always a pleasure to me to hear from my old pupils. I remember you very well and since you have reminded me of it I remember distinctly of taking your sister with me to Chilocco when I left White Earth. If I should remain in charge here for any length of time I hope to get out among the outing pupils and see some of them in their country homes, so if you should not come to Carlisle while I am here I hope to be able to see you in your country home.

As to your eyes I am very much interested to know whether or not anything can be done for them. I am informed that Dr. Fox, of Philadelphia, has for many years treated the eyes of our pupils free of charge. I wonder if your country mother could not take you to Philadelphia to see Dr. Fox. If so, let me know at once and I will write to him and make arrangements for you. He is, no doubt, a very busy man and it will be necessary to notify him several days in advance in order that he may arrange a date to see you. I believe we have an arrangement whereby pupils who have to remain in the city for treatment get their board at some hospital in Philadelphia for \$1.00 per day.

Your eyes are worth more to you than your books, and while I do not feel justified in departing from the rules of the school in your case until a competent specialist has examined your eyes, still I feel that it is very important that you attend to this matter at once, even should it be necessary for you to remain out of school for a while in order to do so. Please show this letter to your country mother and after talking the matter over with her let me know if she can arrange to have you go to see Dr. Fox and when.

In your letter you speak of my little daughter, Lucile. She is now quite a good sized girl and when I write to her I will tell her about you. With kind re-

SUGGESTIONS FOR SUPPLYING THE INFORMATION REQUESTED ON THIS BLANK

1. The report of nonreservation school Superintendent should be made at the time or a little before the pupil leaves school, whether at the end of the school year or during the school year, provided the pupil is 18 years of age or over, or younger, if for any special reason the pupil is quitting school permanently. As soon as this report is received, or at least very soon after the pupil returns home, the Supervisor of Indian Employment will correspond with the returned student for the purpose of getting more in personal touch with him and finding out something about his wishes, etc. His answer will be attached to and filed as part of this report.

2. Health, height, and weight of returned students are sometimes very important in placing them properly; height and weight could be approximated very satisfactorily, though from the pupil records now in use all information called for in part 1 of this blank can readily be obtained and be definite.

3. The State, agency, and tribe are important, and where the pupil is not attached to any agency this fact should be stated and the Superintendent should give all available information as to the home and local conditions surrounding the pupil.

4. Where the outgoing pupil has passed the civil-service examination for any position, this fact should always be noted, giving position for which examination was taken.

5. It should be remembered that the Supervisor of Indian Employment can but seldom have a personal acquaintance with the outgoing student, and that he must depend on the information furnished in this report for his basis of action in behalf of the pupil.

6. The degree of Indian blood should always be given, as this fact largely determines how much effort will be made on behalf of any particular returned student; qualifications being equal, or nearly so, the preference will be given to those having the greatest degree of Indian blood.

7. This report should be forwarded promptly to the Supervisor of Indian Employment, Indian Office, Washington, D. C.

8. Reports on students from reservation schools should be made only as to those who leave the schools at 18 years of age, or older, and who will probably not go away to school.

9. If part 1 of this report is made out by the principal of a reservation school, the reservation Superintendent should supply information called for in part 2 if the principal is not informed as to home surroundings and local conditions. Such information is essential to a proper understanding of the difficulties and needs of the pupil.

10. When part 1 is made out by a nonreservation Superintendent, this blank will be sent by the Supervisor of Indian Employment to the Superintendent of the reservation where the outgoing student belongs. He should fill out part 2 and return the blank as promptly as possible, for practically nothing can be done until the information called for in part 2 is supplied.

Information under the heading "Employed since return as follows," will be valuable only in cases where the pupil has been home for some time.

My dear Friend:

Upon receipt of your letter of the 2nd instant I had inquiry made regarding the work you have completed at Carlisle and learned that you were a very excellent worker in whatever department you were placed. I also learned, however, that last year you made the plea that you should be allowed to discontinue your academic studies because you believed yourself too old to make the progress that was expected of you. That being the case it would not be advisable for you to take a course that requires as constant study as does the one outlined for the training of nurses.

Believing that you would do better as an employee in the Indian School Service I beg leave to suggest that you apply to the Commissioner of Indian Affairs for an examination to test your fitness for appointment to a position where your duties would be along the lines of work you desire to do. If your letter is addressed to the Commissioner and sent here it will be forwarded to Washington with a recommendation and a
