SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.

Noting in your favor of the 20th instant that Margaret Bradley's mother is too desperately poor to expect her to lend assistance in arranging for the return home of the girl, it has been planned so that Margaret can leave here on Wednesday afternoon of this week. A ticket for her passage to Ela will be provided for her use to be paid for from Government funds.

Margaret has an amount of \$14.34 to her credit in our school bank and I have had instructions issued that not less than \$7.00 of the amount be retained to be given to the girl when she leaves here to pay for incidental traveling expenses enroute home.

My dear Mr. Lipps:

I have your letter of the 13th, saying that your school physician had recommended that Margaret Bradley be returned to her home, and, asking that in view of the fact that she had only been enrolled at your school for so short a time, that her transportation be paid from personal funds.

It would seem from Margaret's statement to you that I have been guilty of sending you a sickly pupil. As to the matter of her having been seriously ill prior to going to Carlisle the matter was never brought to my attention. My recollection of her case was that she was not considered as robust as someother pupils but this was not sufficiently serious to hinder her progress in school.

The mother of Margaret is desperately poor and has a large family of illigitimate children and I am sure she would be unable to furnish the necessary transportation for her daughter without taking some of the necessities of life from her children.

Dear Mr. Henderson:

Our School Physician has recommended that Margaret Bradley be sent home before the beginning of next year's work and when the girl was seen at this office this morning she stated that she had frequently been ill prior to her coming to Carlisle. In view of the fact that she has been enrolled here but a little longer than six months and has been in poor physical condition for several months of that period it seems that personal funds should be used to provide transportation for her return home. However, if her parents are not in such circumstances that they can well afford to send money for her transportation it will be arranged to send her home at Government expense.

I would thank you to let me hear from you at your earliest convenience.
