SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

Henry McKay is younger and aside from this whiskey deal has been a good student.

He promised me that if given one more chance he would make good, I therefore ask that Mr. Lipps grant Henry's request.

Dear Sir, Mr. Geringer requested me to write you about my intentions. I think that I ought to be at home, as I have stock of my own to care for. I intended to go under the outing in some shop and to use the money I earn to pay for some cattle that I bought from the Government under an reimbursing agreement. Under the present conditions it is useless for me to stay here.

I can make good at home, because there are no evil influences there as there is here. I never touched a drop of liquor before I came to this school. What little I have drank has been given to me here by students of this school.

I don't feel as though I have been given a square deal. I have never been accused of drinking before, and have made a good record in my industrial department.

While some of the boys that are in the Ford Shop are the ones that led me in wrong, and then went to Detroit with the Carlisle Indian School back of them.

I know all of them well. I traveled with them all fall, and I know that most of them were drinking on the trips. On the last trip they were drinking as usual and the matter was reported to the school, but yet they were recommended. I worked hard all summer for \$75 a day, and during Mr. Weber's vacation I was in charge of the engineering department, while all the other shops were drawing a dollar a day. I never objected as I was in hopes of going to Detroit in the fall.

I was blamed for influencing some of the boys to march out of the back

door of the dining hall because Mr. Geringer had just announced that that we were not to use that door, I was not in the bunch that came out the back way. I was also told that you thought that I had a bad influence over the boys.

I left my reservation with a clean record, and now everybody at home thinks that I am a drunkard which is not so. I was never drunk in my life. I only took one drink with Edwards, but as I was working with him the disciplinarians naturally thought I must have been drinking to. I could have easily hid out of it.

I was not given a suit of clothes by the Athletic Association, which I rightfully earned.

The only chance I want is to leave here with a clean record. I will try and get money from home to pay my expenses.

My dear Sir:

This is to acknowledge receipt of your favor of the 4th instant in behalf of Chauncey Williams and those who will be embarrassed with him if his release from Carlisle has to be effected while he is not in good standing. I appreciate fully the situation in which Chauncey and those closely related to him will be placed, but his attitude is such that his request to return home should be granted for his own good and the improvement of the discipline here.

Chauncey's indulgence in strong drink is not the only reason why it is undesirable to keep him here. He has shown a general disregard for the simpler rules of the school upon which so much depends and since his release from the school guard house for his latest offense he has refused to be in line for the usual roll calls and the prescribed drill by the Troop of which he is a member. He is not taking any academic work, but I must state that he has made an excellent record in his work in our plumbing shop and wherever he has

had physical labor to perform.

He states that he purchased cattle under the reimburse-
able plan and requests that he be given permission to go home
to care for his property, and in view of the fact that he is
not doing any good here it is believed advisable to effect his
release just as soon as the amount required to pay for his
transportation is made available so that he may have the op-
portunity to take care of his property.

It is especially deplorable that only at Carlisle has
the young man had so unsatisfactory a record, but it is only
fair to add that after an enrolment of six months in 1912 and
1913 he deserted just four days after his brother DeForest or
Fred had taken similar leave. Since his return to Carlisle he
has been a constant source of annoyance to those in authority
because of his apparent unwillingness to do what he knew was
required in the way of conforming to certain rules upon which
the proper handling of several hundred boys rooming in one
building must depend, and while I regret very much that Chaun-
cey will not make an effort to regain our confidence it will
be appreciated if you can cooperate as is required to effect
his return home without delay.

Dear Sir:

I have your letter of January 27th with reference to Chauncey Williams and I regret very much the conditions you mention with reference to this boy and, while I do not question the justification for your action, still I desire to say a word or two, particularly with reference to the family.

The Williams family is one among the best families on the reservation and I cannot help but think that this young man will see the error of his way and brace up. If it is consistent at all, at this stage of the proceedings, for you to talk this matter over with him and explain to him just how it would affect his family and his friends and others here that are interested in him, I believe that he would take a new tack and proceed to make good. Our records show that he is 20 years of age and I am

hopes that he has pride enough at this time to ask your further indulgence and that you will give him another chance. At this time he has no funds to his credit now is he likely to have any soon.


I wish you would tell him for me that his record at Carlisle will have a great deal to do with conditions here, so far as he is concerned. He should know that we keep a file of every Indian on the reservation and furnish a copy of the same to the Indian Office and the history he is making now is a matter of permanent record in his case and that he will regret very much, later on, if it becomes necessary for Carlisle to take the step it is now contemplating. I believe with you that if he is not disposed to do the right thing that he should pay his expenses back to the Agency or wherever he plans on going and that the Government should not further assist him until he shows a disposition to do the right thing.

I wish again to appeal to you, particularly on account of his mother and immediate family. He has a brother now in the Service, slightly older than he is, who is making good and this step on the part of

Carlisle would be a great humiliation to his brother.

Please keep me advised as to the history of this case and if I can do anything towards the reclamation of this boy I will certainly be glad to do so.

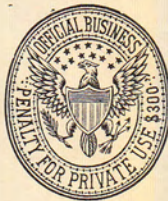

My dear Sir:

Replying to your letter of August the 31st, with which you transmitted a communication that was addressed to you by Mrs. Helen Williams in regard to her desire to have her son Chauncey enrolled at the Haskell Institute, this is to advise that there is very little information in our files here regarding the efforts he made to advance himself.

It has been reported to me that Chauncey came to Carlisle with the idea of taking up High School or College Preparatory work outside of this school. It seems, however, that he did not begin such work and that later he was given permission to enter the Senior Class at this school. A report just received from our Principal Teacher indicates that he attended classes but for a short time in October and that he was not even given a mark for the work he did.

The records kept at our School Hospital indicate that Chauncey was a patient there from January the 28th to February 19th and that he made a good recovery from the attack of

tonsillitis and bronchitis from which he suffered.

The information on file here, with that given me by those who knew Chauncey personally, leads me to believe that he evidently did not know what he wanted to do when he was at Carlisle and that he was not willing to profit by what could be done for him here.

I shall not object at all to his enrolment at the Haskell Institute, but could not recommend the expenditure of government funds to give him the chance his mother desires for him.


Dear Sir:

There is inclosed herewith a letter from Mrs. Helen Williams, an Indian of this reservation, with reference to the enrollment of her son, Chauncey, at Haskell Institute. This young man enrolled in your School about a year ago and deserted after having been in attendance a short time.

You will note that the mother gives the damp climate of Carlisle as the reason for his desertion. If this is a reason and not an excuse and your physician will give a certificate to the effect that your climate was injurious to the young man, I might feel somewhat justified in recommending him for enrollment at Haskell; however, unless it is a question of his health, it is my opinion that he should return to your School at his own expense if he attends an Indian school.

Please return the inclosed letter with your views on the matter and also advise whether you will consent to his enrollment at Haskell.



My dear Mrs. Williams:

When your letter of the 16th instant was received here this morning I had it arranged at once to see your son Chauncey ^{Williams} once more in my office. After I had talked the matter over with him and appealed to him once more on your account he finally consented to try to make a better record than he has made. At first he was not at all willing to do anything for himself and repeated his request that permission be given him to go home. I assured him that if he will show the right attitude and will try to do what is required of all our boys I will gladly recommend him to go to Detroit, Michigan, after the close of this year's work to begin the course of instruction that is given to boys of this school in the Ford Motor Company's factory.

In this connection it is only fair to state that to very few boys enrolled here have I given as much of my personal time as I have given to your son. Let me state again, however, that he is not at all vicious and that even his in-

dulging in strong drink could have been condoned if he had not so utterly ignored heretofore all the rules upon which must depend the proper handling of so large a group of boys as we have here. His failure to report promptly for roll calls and his failure to get the required permission when he desired to leave the school grounds has made it extremely difficult for Troop officers to keep control of others enrolled in the same Troop of which Chauncey is a member and when he insisted on going home I felt it was probably the best we could do for him. I believe we have had more patience with Chauncey than with many others enrolled here because he has been so excellent a worker and has made so splendid a record in the department under our school engineer.

The failure to send you reports regarding him has been due to the fact that he has not done any academic work, as reports are sent out from Carlisle with the monthly "home letters" that are written as a part of the academic work. It is the aim here to let all parents have reports regarding their sons and daughters and I am having it so arranged that hereafter reports will go out regarding those who do not take the academic work as well as those who do write monthly letters.



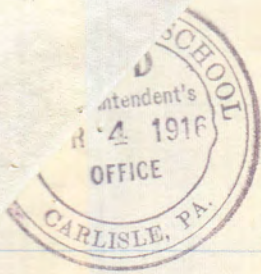
