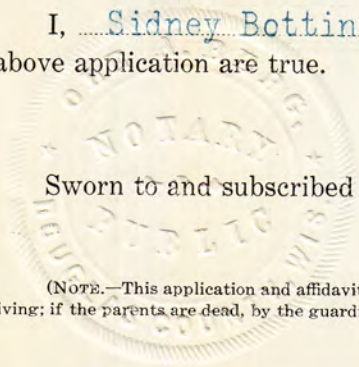

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

Dear Emerald:-

I have Miss Johnston's report of her visit to you, also your letter. I feel that you have acted very unwisely. You have not lived up to the rules of the Hospital as you should. You have not taken the advice or even orders from your superior officer in the manner you should. You did not consult me but took matters into your own hands and left the Hospital. Your chief aim seems to be to have a good time and you are willing to sacrifice your training, your health and your general welfare in other ways, to get this good time.

In view of the above, I do not think it wise to advise you to return to the Hospital. I think it best that you go home where you can be in the care of your own people. You can let me know when your money comes from home and when you leave for your home so I can have your name taken off the school list here.

I hope that you will in time see the mistake you have made in not finishing your training at the Lancaster Hospital and I trust that when you have fully regained your health, you may again take up the work in a profession for which you have a natural aptitude.

Dear Mr. Lipps:-

The enclosed telegram from Emerald Bottineau in training at Lancaster Hospital was received Saturday, May 6, 1916. On Monday, I went to the Lancaster Hospital and received the following report from Miss E.C. Taylor, Superintendent of Nurses at the hospital.

Miss Taylor took charge of the nurses in February of this year. New rules were put into effect. Emerald seemed to resent the new order of things. Whenever a privilege was given her, she took advantage of it and went just a little further. She remained off duty for every little ailment.

She suffered with throat trouble and on March 23rd had her tonsils removed. She remained in bed or off duty at the time four or five days. From April 12th she was off duty for three days, again on April 27th and 28th she was off duty. On May 4th, she was given a "long day". This means a whole day of rest or a day to spend as she saw fit. On May 5th, she said she was ill and did not report for duty, neither did she report on May 6th. Miss Taylor was in to see her on both days. The hospital physician said he found nothing real wrong with Emerald's health but he ordered some medicine and a diet for her.

Emerald told Dr. Hartman and Dr. Apple that she had decided to quit training and would go to Mrs. Gibbel's home until she was well and later leave for her home in Wisconsin. She further stated to the two doctors and Miss Taylor that Carlisle had no control whatsoever over her. The doctor ordered her to remain in bed and when she was better she should go on duty. These orders were disobeyed. Later in the morning when an attendant went to attend to her needs according to the doctor's orders she found that Emerald had left. This was Saturday morning, May 6th.

Miss Taylor further reports that Emerald had a pleasant cheery disposition and was well liked by the patients. As a nurse she was a hard worker, -was not a loafer, but she was not thorough. She was inclined to slick things over. She spent money freely, had too many clothes, was the best dressed girl in the institution, was always receiving boxes by express, flowers, etc.

After her tonsillitis operation and time was given her to recover, instead of caring for herself she got up and went automobiling. In fact, she went automobiling at every opportunity. The party with whom she went most frequently is a Mr. Hall. I learned that this young man has no definite employment.

Ozetta thinks that Emerald has been dissatisfied with training for some time. Ozetta says that Emerald told her she had no nourishment Friday or Saturday. Miss Taylor reports that Emerald refused what was sent her.

From Ozetta I learned that Emerald had taken a room at 565 W. Walnut St., Lancaster, with a Mrs. Gibbel, an aunt of Emerald's room mate. I went to see Emerald at this address but found that she had left at eight o'clock that morning on an automobile trip for Philadelphia in company with Mr. Hall and his mother. She would not return before seven o'clock that evening. She left the enclosed note for me.

Since Emerald after telegraphing to me did not consider the situation serious enough to warrant her remaining where she could be interviewed, I doubt if much or any consideration can be shown her. If she were not well and found the hospital training too arduous, there was a proper method to take for honorable discharge.
