Referring to your letter of the 17th ultimo in regard to the return home of Donald Brown, I can now report that authority has been granted to keep him at Carlisle until the close of this school year if satisfactory arrangements cannot be made before that time to have him placed in some other school.

Just as soon as it is decided by the sisters what they desire to have done for Donald I will gladly cooperate further as may be required to effect his release for the purpose of continuing with his school work elsewhere.

For several months Donald has devoted all his time to the work at his trade in our Printing Department. Permission to discontinue his academic work was granted him at his request.
