SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.

CARLISLE INDIANS HOMESICK.

JOHNSTOWN, Pa., June 22.—John Allen, 21 years old, and John Bouchard, 18 years old Sioux Indians were arrested in Conemaugh, near here, to-day and were lodged in the lock-up. They confessed that they had run away from the Carlisle Indian school and were trying to get back to their homes in Montana. The Redskins said they had left Carlisle on Sunday and had got this far West by walking, after riding as far as their money would take them. The Carlisle Indian school will send an officer for the youths to-morrow.

Dear Sir:

I am in receipt of a letter from John Allen, a pupil in your school, whose home is on this reservation, in which he states that he has finished the course in plumbing and electrical engineering in your school, and that he wishes to return home in order that he might make some use of the training you have given him. John has been at Carlisle about three years and I hope has made good use of the time.

There is no work in his line on the reservation and the opportunities for such a mechanic are quite limited in the small towns adjacent to the reservation. It seems to me it would be well if you could place John in some position where he could have an opportunity to earn something and become more proficient in the trade you have given him. His mother lives at Lodgepole, Montana, on this reservation, but the family is not enrolled here for the reason that they participated in some tribal benefit at Santee or Sisseton some years ago and were therefore dropped from the rolls at this place.

You may read this letter to John, and tell him that I do not care to make any recommendation in regard to his return, but that I hope you will do what you think is best for him.

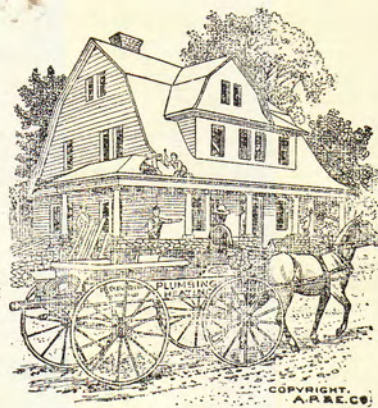

Dear Sir - Yours of 19th received when I came home Saturday night from Hallstead Pa. Supposed John Allen had replied to your letter and matter decided although he volunteered no information.

This morning he decided to stay. I laid matter frankly before him, stating that if he intended to start shop, the experience would be invaluable as it could not be acquired in large shop.

He has kept last week to install pneumatic system in connection with bath-room, has had experience on small steam & hot water heating, removing & replacing tubes in high pressure boilers, pumps of different types &c.

I also suggested the necessity of studying the different methods of installation, reading the journals devoted to the trade, laying out work in his mind as to how he would do it if left to himself, then watching how others do it, and reasons for so doing. He is not as ambitious as Luther Jacobs, but can do better work.






