SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school shall be furnished with the original of this form for his files, and the duplicate shall be deposited in the office of the superintendent in charge of the reservation. The Reservation Superintendent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer. 6-870

## INDORSEMENTS.

---

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

*Provided*, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

That no Indian pupil under the age of fourteen years shall be transported at Government expense to any Indian school beyond the limits of the State or Territory in which the parents of such child reside or of the adjoining State or Territory. (35 Stat. L., 781.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case; but in all cases where the parents are living they should first be consulted.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.



Dear Mr. Dickens:

I submit below for your information a copy of a self-explanatory report that was handed to me this afternoon by our School Physician, Dr. Rendtorff:

"I recommend to you that Jessie Daisy be sent home. This child has a tendency toward hip joint disease, a condition which with rest, fresh air and the beneficial influence of the home surrounding may clear up. I feel that the routine work and drilling, combined with indoor study, are detrimental factors in her case and that active tubercular hip joint trouble may set in under these conditions."

In view of the fact that Jessie's three year period of enrolment at Carlisle will terminate at the close of this school year there can be no objections to sending her home as is recommended. However, before such action is taken I would thank you to advise me by letter or wire whether there is any reason why she should not be sent to her home at this time.

Upon receipt of your letter of the 21st instant in regard to the conditions at Jessie Daisy's home it was referred to our School Physician for his information and guidance. He too realizes the importance of keeping the girl at Carlisle for her own protection and good and has just written a statement as follows:

"I suppose under the circumstances and with the view of working good and not harm it will be necessary for us to retain Jessie Daisy. I will treat her at the hospital whenever necessary and keep close watch over her condition. She has been excused from all heavy work and strenuous physical exercise. 
Dear Mr. Lipps:

I have your letter of the 16th instant relative to the case of Jessie Daisy. I am very sorry that Jessie should be afflicted in the manner indicated and regret to say that her home surroundings cannot benefit her morally or physically. I do not know, of course, what in the world you could do with her other than to send her home but if there is anything that can be done, I would advise to that end. Jessie, as I remember her, was a grown-up girl with a mind of a six or seven year old child. I have received several letters from her, both from Carlisle and her outing residence and she seemed to be the most hopeful of any of the pupils. I had occasion, just before sending her away, to call her to the office and ~~reprimand~~<sup>reprimand</sup> her. And had she not shown such a disposition as to want to do better, and seemed to really want to go to school, I would not have recommended her for Carlisle. I think Jessie is all-right but her home surroundings and influences are very much against her and if there is any other thing that can be done, I



Dear Mr. Dickens:

I have given the matter of allowing Jessie Daisy further school privileges my careful attention and have finally decided to suggest that perhaps Jessie could be admitted to the Flandreau School.

As our school physician has requested that permission to have her return here be refused I cannot allow her to come here. For the last several months she was with us she must have annoyed our physician with requests to go home on account of the affection in her hip and because she felt she could not wait until her period of enrolment had terminated. As the same thing might be repeated here and the expense of transportation to come so great a distance is more than should be risked in taking a chance with Jessie the closer location to Red Lake of the Flandreau School should remove the latter objection. It might possibly be arranged to have Jessie pay for her transportation and to place on deposit an amount that could be used to pay her fare to come home if it was learned that her physical condition would not allow her continuation

in school thruout the year or her term of enrolment.

Only because you were so pleased with the wonderful change Jessie accomplished for herself while at Carlisle and because she made so excellent a record here do I take the liberty to offer the suggestion that she be allowed to go to Flandreau.
