Lizzie made application to go out under the outing system, and it was at her own request that she was permitted to go. She said that she had written to you telling you that she was going to the country, but that you never replied to her letter. Our Field Agent, Miss Johnston informs me that she has visited Lizzie three times since she went out on April 9th. I will have Miss Johnston visit Lizzie again very soon, and if we find that she continues to be unhappy and lonesome, we will return her to the school. Most of the boys and girls get lonesome and homesick after leaving Carlisle, but they soon get over it and many of them become very much attached to their country homes.

We will do what we think is best for Lizzie's welfare, and I hope you will have no uneasiness about her.

Dear Mr. Lipps:

Lizzie Lieb made application to go on the Outing on Feb. 24th. She tells me that she wrote to her grandfather in her home letter that month that she was going to the country. She tells me he never replied to her letter. It seems to me that had he any objections to her going on the Outing, he had ample time between that date and April 9th to state these objections. Lizzie also tells me that she wanted to come to the country "to learn".

I have visited her three times since she came out, April 9th. I felt she was none too robust so placed her accordingly. Lizzie tells me she does not like children. The work is not at all hard- two in the family- Mr. and Mrs. Waller and Mrs. Waller expects to teach a girl. I had a long talk with Mrs. Waller on April 17th, suggesting such things as I thought would be helpful to Lizzie's training and contentment.

True, I am sure Lizzie will be lonesome - most of the girls are at first but that will wear off in her efforts to become interested in her work. Mrs. Waller says she finds - Lizzie very forgetful when given directions-but seems willing and obedient. I judge the forgetfulness is due to disinterestedness as she ~~she~~ never fails to forget that which interests her personally, such as having her numerous letters written and laid on the window sill, ready for the mailman when he calls.

The cause of Lizzie's unhappiness lies in this fact:- she repeatedly forgets and when told over again she becomes discouraged and blue and thinks she cannot learn -wishes she had never come to the country, etc.

Here are some of the instances - had to be told three times to always wash glasses first in dishwashing- cannot remember to put coal on to keep up a small fire this warm weather-fails to remember about wiping the stove, and various other little things. I think the child feels swamped and never having any of these duties before, naturally thinks the best way out is to go back to Carlisle where she will not have any of these things to do.

In my judgment it would be very unwise to give in to her feelings to make an immediate change. Ten days in a home is not a fair test for either Lizzie or Mrs. Waller, but in my talk with both we have decided, subject to your approval, that if Lizzie still continues to be unhappy, that at the end of the month, on my next visit, I will make a change of home for Lizzie.
