SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the reservation school records. The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

The enrollment of Indian pupils in nonreservation schools is governed by the "Rules for the Indian Service, 1913," sections 12, 13, 14, 15, 18, 19, 36, 112, 113, 114, 117, 118, 124 (b).

The Rules should be consulted before filling out the application blanks.

My dear Sir:

Phillip Sellew, who was enrolled here thru your assistance last September, has recently had to be returned to school from his outing home because he was losing weight. Phillip is growing very rapidly in height and the development of his body does not seem to keep pace with that growth.

Our physician has had him under observation in our hospital and does not seem to be very favorably impressed with his case, so has suggested that taking him away from the confinement of school life should benefit him. In order, therefore, that it can be determined what should be done it will be appreciated if you will advise me what the conditions at Phillip's home are and whether or not his people are financially able to pay for his transportation home if his release is effected.

I have received your letter of the 4th instant in regard to the condition of your brother Philip's health and must state in reply thereto that he was provided with a ticket for use to Browning and that he left here on the 2nd instant to go to his sister's home.

Thru the kind cooperation of Superintendents Breid and Ellis it is to be arranged so that Philip can be admitted to the Fort Lapwai Sanatorium at Lapwai, Idaho, to have the advantage there of being given the special treatment that is afforded. Our school physician diagnosed his somewhat weakened condition as the result of an incipient tuberculosis, but Philip is young and should have a very good chance of regaining his health.

Hoping you will not hesitate to advise me what further assistance can be given from this end, I remain,




Dear Mr. Lipps:-
