
Dear Mr. Hinton:

I have your letter of the 20th instant relative to the enrollment of Napoleon LaDuke and his brother Benjamin at Carlisle, in which you ask as to whether I can recommend these boys for transfer to that school.

In answer I have to say that I regret that I cannot recommend the boys for any school. Napoleon, or Pat, the older of the two, was a confirmed runaway and malcontent while here. Bennie was much smaller, but seemed to be rapidly developing the characteristics of his brother. Their career in Pipestone School culminated by their mother coming here and stealing them out one night. This occurred after Napoleon had run away a number of times and had been returned. Bennie, I believe, had also run away several times. In view of these facts I feel that it would be wrong for me to recommend them

for transfer, but at the same time I have no objections to their transfer to Carlisle, if the Superintendent of that school wishes to take them. I would not, under any circumstances, enroll either one of the two boys in this school again, unless compelled to do so by an order from the Indian Office.

Dear Sir:

Referring to your letter of Oct. 7th in which you request the return of the two ^{Napoleon} LaDuke boys and Georgiana Belcourt, I have to advise that arrangements are being made to have the LaDuke boys leave here on Thursday evening, Nov. 2nd. I am sending them to their mother, Mrs. O'Donnell, 149 State Street, St. Paul. We are doing this because from Supt. Mann's statement these boys are deserters from the Pipestone school and are not eligible for enrollment in any other Indian School.

As to Georgiana Belcourt I am somewhat at a loss to know what to do with her. I hesitate to send a girl of her age so great a distance alone. While we do not care to keep her here, still if you think it best to do so, we will do the best we can for her.

I am advancing the LaDuke boys each \$2.00 cash to pay for their meals enroute, and you can send me this amount,

together with the cost of their tickets from Erskine to Carlisle and return from their Chippeway payment money. The cost of their tickets from Erskine to Carlisle was \$34.72 each and from Carlisle to St. Paul, \$25.38 each, making a total due the Carlisle school on account of these two boys, including the money advanced for meals, of \$62.10. each.

Dear Sir:

There is inclosed herewith the approved application of Lizzie Antell for enrollment in the Carlisle Indian School. It is my understanding that she went to Carlisle in company with Mr. Frank Cajune on October 3rd.

It is my understanding that the following pupils from this reservation ^{also} accompanied Mr. Cajune to Carlisle:

Georgiana Bellecourt, Henry (Bennie) LaDuke, and
Napoleon LaDuke.

I am informed by the principal of the White Earth Boarding School that Georgiana Bellecourt is not eligible for transfer to the Carlisle Indian School, for the reason that she is in the third grade. The principal further advises me that he wrote to Mr. Cajune, and explained this matter thoroughly to him. He should not have taken this girl away from this reservation.

Napoleon LaDuke and Henry LaDuke were enrolled in the Pipestone Indian School, and should have returned to that school if they went to any non-reservation school. These two

boys thoroughly understood the situation, and knew that they could not enroll in the Carlisle Indian School. Both of them attended the White Earth Boarding School for a short time last year. Henry is in the third grade and does very poor work in that grade. Napoleon LaDuke was in my office sometime ago, relative to his going to the Carlisle Indian School. I explained to him that his record in the Pipestone Indian School had been an exceedingly poor one, and advised him to prove to me his good intentions and his ability to conform to discipline by attending the White Earth Boarding School for a time sufficient to test his worthiness for transfer to a non-reservation school. I am unwilling to approve his transfer to your school until he complies with my request in this respect. For your further information I inclose herewith a letter received from Superintendent Mann, of the Pipestone Indian School, relative to the transfer of the LaDuke boys to your school.

The three pupils whose applications are not approved should be returned to this reservation. In a short time they will have money to their credit, and if you care to advance the money for their return transportation, I will see that you are fully reimbursed.
