INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

My dear Mr. Lonergan:-

I am sending to their homes at Seama, New Mexico, James Chaves and Harvey Concho, two Pueblo boys who have finished their five years term at this school.

James Chaves has been an excellent boy during all the time he has been here. He has worked on farms under the Out-
ing most of the time he has been here, and has a splendid record as a worker. He has saved One Hundred Seventy Five Dollars of his earnings. He has drawn Sixty Dollars of this amount leaving a balance of One Hundred Fifteen Dollars to his credit. He has asked that this amount be kept here for a time.

Harvey Concho is an excellent worker and has been a good boy with a few exceptions. About a year ago he raised three checks. As they were his own checks and he had money in bank, it was not such a criminal act. I do not think that he realized that he was doing anything so very wrong. He had saved Ninety Dollars and Ninety Cents of his wages and has drawn Sixty Dollars of this amount leaving a balance of Thirty Dollars and Ninety Cents due him. I enclose a check made payable to him for the balance due him. You can hold it for him until such time as

you see fit to give it to him. As this is all money he has earned under the Outing, it will not be necessary for you to take it up as transfer of funds, if you do not wish to.

I trust that these two boys will put to good use the things they have learned at Carlisle. I know that they will appreciate anything you can do to get them jobs.

Your letter of January 13th relative to the return of Harvey Concho home from your school is received and the matter taken up with Mr. Cassady, farmer at Laguna, who reports conditions as follows:

After making an investigation into the family conditions I will have to advise that I can see no necessity whatever of returning Harvey home to help his father for the following reasons:

His father is healthy and stout, and he has another boy at home 16 years old, who does not go to school any place. He has another boy 11 years old in the Seama day school, and a girl 7 years old in the Seama day school. Both of these children are at home mornings and evenings, Saturdays and Sundays.

Therefor, I would suggest that the boy be kept in school till his term expires.


