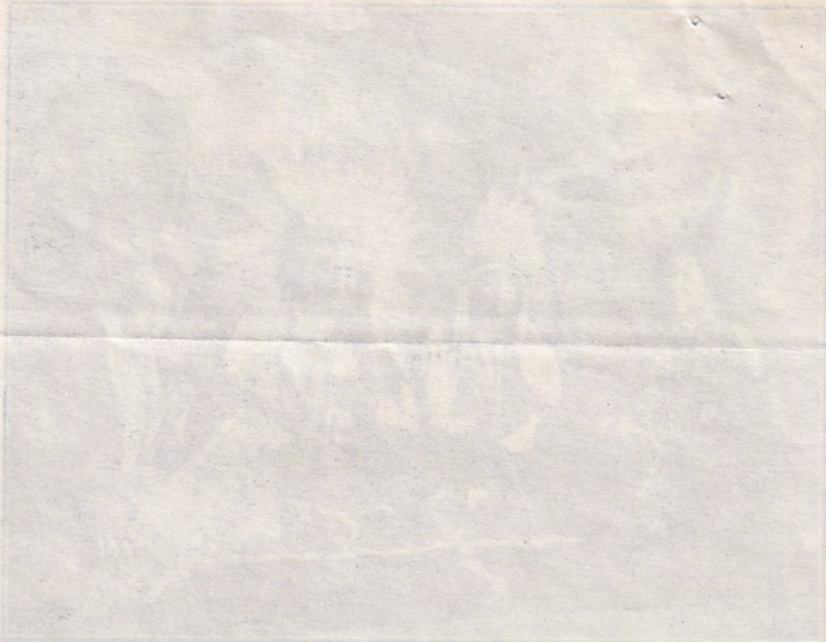

Dear Sir:

I have noted the request that is contained in your letter of July 16th, but must state in reply thereto that I cannot agree to let your son Daniel travel with you if you expect to have him return here later to resume his studies. If you do take him with you it must be with the understanding that you will assume the care of him and that his return here cannot be effected. I appreciate your expressions of gratitude for what Carlisle has done for your son, but if you take him into the Indian show business I fear you will undo all that we have done for him.

In regard to aiding you by letting Daniel wear a Carlisle uniform I must state that the practice of engaging in a show business of any kind is directly opposed to what we try to teach our boys and girls. We endeavor to have them gain a knowledge of some trade so that a home can be established when their school days are over and in which they can make an independent living by their efforts. Favorable consideration cannot be given your request, therefore, to let you use

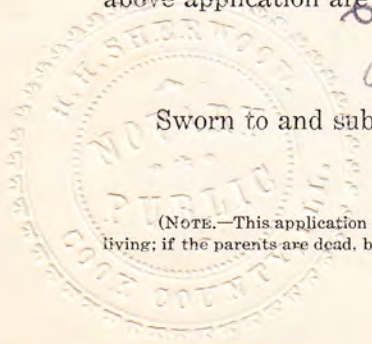

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.




My son Daniel Arapahoe

Dear Mr. Lippis:-

Well I might as well tell you ^{what} I have had in my mind now ever since I went to the Carlisle Indian School.

You know I went there to see my son and to find out how he was getting along in his studies and in work. But instead, I was highly disappointed when I went there and found out that my son was sent home. And when I heard it I was nearly shocked down to the ground in fact I cried Mr. Lippis

and I am not ashamed to tell you or any other man.

And now what I must do I do not know. My boy was sent back to the reservation but I sent for him and so he is now here with me I thought I could send him to some other school but I don't think I can. I thought about sending him to a school but I know I could not afford to pay for his schooling. Mr Lipps this is the way I think of the future that is to come and my boy without

any education and no trade. Why what do you suppose would become of the family, a poor Indian like me with out any education and no trade why you ought to know that a poor man like me needs a son with some education and trade so he can take care of his father + mother and make a good living of his own.

Now my boy was eager to learn but just that crazy spell got into his head and he went.

and done it before he
thought about it. And
now I don't know what to
do to stop him from
worrying so much every time
I ask him what he was
so lonesome and worrying
about he says I want to
go back to Carlisle he
tells me, "Gee father I
wish I was back to dear
old Carlisle again".

Now Mr Lippa I know
he could do a whole
lot better if he was
at a school now because
I told him, I said
my son you are always

wanting to go to school
and if you do like you
did over there at Carlisle
Indian School and get
sent home, I am going to
kick you right out of the
house and I don't want
to see you any more.
And every thing I say
goes too no joking
about it either.

Now Mr Lypps you have
been among us Indians
nearly all your life and
you are a good friend to
the Indians and the
Indians treat you right
any one of them that you

treated as he ought to
be treated.

My boy tells me that
you had already given
some of the boys that were
worse off than what he
was and gave ^{him} another
chance and they have to
be good because they
know they're only got one
chance in this wide
world to get started in
life's business. And you
haven't given my boy
any chance at all.

So Now Mr Lippes I
am going to ask you
to do me just one favor

a favor that I am depending upon either on my boy's side or life.

And that favor is this. "Please" Mr Lippe open your kind heart and give my boy just one more chance a chance that I know he will depend upon in this world. I will pay for his transportation down there and will also send enough money in your bank so that any time he gets into mischief first thing buy him a ticket and ship him home to me and

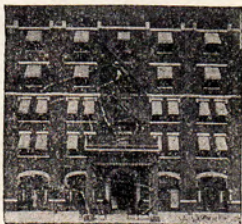





Dear Sir:

I have noted the request that is contained in your letter of July 16th, but must state in reply thereto that I cannot agree to let your son Daniel travel with you if you expect to have him return here later to resume his studies. If you do take him with you it must be with the understanding that you will assume the care of him and that his return here cannot be effected. I appreciate your expressions of gratitude for what Carlisle has done for your son, but if you take him into the Indian show business I fear you will undo all that we have done for him.

In regard to aiding you by letting Daniel wear a Carlisle uniform I must state that the practice of engaging in a show business of any kind is directly opposed to what we try to teach our boys and girls. We endeavor to have them gain a knowledge of some trade so that a home can be established when their school days are over and in which they can make an independent living by their efforts. Favorable consideration cannot be given your request, therefore, to let you use

While Daniel has improved in many respects while a pupil here, I felt that the school has about done all it could for him, and so decided that the best thing to do would be to send him home. I understand his father is a show man and is located somewhere in Chicago. As I could not get his address and Daniel told me he had relatives at Pine Ridge, I arranged to send him out there. I am sorry that I cannot give a very good report about this young man.

As Daniel had no funds here I advanced money to pay his transportation. If he has any funds in your hands, I would appreciate it if you would send me a check for \$42.00, which would cover all his expenses.



It seems to me that considering the attention given him here, he was making very little progress. You remember that at one time we refused to have him return to the school, but we did so finally because of your urgent appeal for us to take him. We did this at that time under protest and we see now we made a mistake in allowing him to come back.

He was sent home about a month ago because we all felt that Carlisle had done all it could for him and that as he had not profited as he should by the training we tried to give him, there was no use to keep him any longer. He preferred to go to his relatives on the Pine Ridge reservation, we paying his fare to Rushville, Nebraska.

I am sorry I cannot give you a better report of Daniel, but I have told you just the truth about him.
