

Here is David Wasase's January home letter returned for better address. David says the addressee is his cousin and guardian; that previous home letters were addressed in the same way; and that none of them came back. Our atlas does not contain the name of any town by the name of Peyton. The theory that there is no postoffice in Okla. by that name would seem to be borne out by the nature of the return stamp; for it seems as if the letter never got any farther than St. Louis. Wasase says he does not know any other address.

Maybe some one in the general office who knows Oklahoma pretty well might call Wasase in and get this straightened out. It seems beyond me.




Sir:



Dear Sir:

I wish to obtain from you an oil and gas lease on your allotment of 200 acres in Section 31, Tp. 11 Range 7 East, in the Seminole Nation. I will give you a bonus of 50 cents per acre and 15 cents per acre royalty for the first year. I have bought some acreage in the same locality for a little less and have paid a little more for some. Thus far there is only a speculative value to this property for oil and gas purposes. Recently a well was drilled to the sand just north of the town of Paden, about eight or ten miles north of your land, and while this well has not been drilled in and no one seems to know whether it is going to be a genuine producer, yet it has caused considerable activity in the leasing business in the north end of the county. I bought a lease on the land of Ahale Marthla about two miles nearer Paden than yours for a bonus of 35 cents per acre and I also bought a lease on the land of Joney which lies alongside Ahale Marthla's, through the County Court where there was competitive bidding, for 50 cents per acre. Please confer with your Superintendent, and advise me whether you wish to lease. If you do I will prepare and send to you for execution under the Supervision of your Superintendent, the usual Department lease, which has to be approved by the Interior Department before it becomes effective. I will arrange to deposit the money with the head of the school or the Union Agency at Muskogee.



Dear Sir:

Replying to your letter of the 15th ultimo regarding a lease upon the land of ^{David} Seminole ^{the Crain} No. 1335, I have to transmit ^{here-} with through Honorable Alexander Crain, the field representative of Hon. Gabe E. Parker, Superintendent, *for execution* I wish you would see to it that the dates are filled in and the bonus affidavit properly signed, witnessed by two persons who sign their names, and then executed before a Notary Public, preferably a Government officer if there be one connected with the school who is a Notary Public. If David speaks English, and I presume he does, the fact should be so stated on the line above "signature of interpreter". Note the instructions on the bottom of the bonus affidavit. The lease should be signed and acknowledged in quadruplicate. When all this is done and returned to Mr. Crain or to me, the lease will be completed and forwarded to Superintendent Parker together with the 15 cents per acre first year's advance royalty and the \$100.00 bonus in accordance with the correspondence heretofore had upon the subject.



I transmit with this letter an oil lease which Mr Jas E Gresham wishes to make with David Wasase, a Seminole Roll No 1335 now in attendance at your school.

I am well known to David and his allotment. The bonus offered is in excess of what has been given for land about it. It and the 15 cts per acre for the 1st year and the \$1.15 for the second year will bring David more than the rental value of his farm and is assured payment. This will permit of David remaining away at school so long as we can make him stay there, a matter that I am anxious that he carry out. These oil leases in no wise injure the agricultural value of his land and adds to his income. For the above reasons I cheerfully recommend that he sign the proposed lease.

If the lease is returned to me I will have David Wasase make such changes as are necessary to make it "regular", or will co-operate as may be desired to adjust the matter with the least possible delay.

I have before me your letter of February 18, 1915, to Mr. Alex W. Crain, which has been referred to me with reference to the offer on the part of one C. Y. Audd to pay \$105.00 as bonus for the oil and gas mining lease executed by David covering the NE $\frac{1}{4}$ of Section 31 and the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 31, all in Township 11 North, Range 7 East, 200 acres. I am filing the leases which David executed to the Soap Oil Company with Superintendent Parker, at Union Agency at Muskogee, and will forward in connection therewith draft in the sum of \$120.00 as bonus for this lease. Our Company agreed only to pay the sum of \$100.00 bonus but in view of this subsequent offer I am voluntarily paying into the office at Muskogee the sum of \$120.00.

The leases executed by David on the 17th of February, 1915, are irregular in the following respects, to-wit: He appears to be enrolled as "David" and is described in the body of the bonus affidavit and in the body of the leases as "David". 
is executed as "David Asasse". In the acknowledgments to all of the leases the name appears as "David Wasase".



I have your letter of August 27, concerning David Wasase, a Seminole Indian young man enrolled at Carlisle, who is not far enough advanced in his studies to profit by the instruction that can be given him in the lowest class that will be organized in your school for the ensuing year, and suggesting that the Mercersburg Academy would be a suitable place for David to be enrolled, as special attention could be given him there. You request that I ascertain whether David has sufficient property to justify the expenditure of about \$500 a year that will be required to pay for tuition, etc., at Mercersburg.

The records of the Agency here do not disclose that David has a legal guardian and he has no funds to his credit. David is a Seminole Indian and of course has an allotment of land, but being in the restricted class cannot dispose of any part of it unless authority is previously obtained from the Secretary of the Interior. It would appear, therefore, that he

has no funds available to meet the expenditure mentioned in your letter in connection with his enrollment at Mercersburg.

I should regret very much if this young man is compelled to return home on account of not being far enough advanced in his studies to remain at Carlisle during the ensuing year. Mr. Alex Crain, Tribal Secretary of the Seminoles, has manifested considerable interest in having David enrolled at Carlisle. I note also you mention in your letter that he is the only representative of the Seminole Nation at Carlisle. In the event he cannot be kept in the school I would thank you to advise me before making any further arrangements.



I have been advised by the bank upon which the check was drawn here in Muskogee that the check had been returned to them for payment through the bank at Carlisle endorsed by David Wolf, and the bank has returned the same on account of improper endorsement. As the check in question should have been returned to this office I would request that when the same reaches the bank at Carlisle for proper endorsement that you recover same and return to this office after obtaining the endorsement of David in order that it may be delivered to David Wolf, the claimant.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.


Herewith a document for your amusement. Written by somebody for David Wasase to Mary (somebody, that girl he is so desperately smitten on).
