SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.





Dear Mr. Lipps:

Twister Littlejohn the step father of Ned Wilnota who recently returned to Cherokee on a visit asked me some time ago to find out whether Ned deposited any funds with which to pay for his return passage to Carlisle. He claims that the boy has showed no special desire to work while at home and has given him the impression that he is a spend-thrift. He says further that he does not feel that though he should pay for his return to Carlisle when the boy has had ample opportunity to save money at Carlisle in place of being without any. I regret very much for Littlejohn to get this impression of our Carlisle boys as he is an influential Indian and a good thinker. I would suggest that you write to Ned and advise him. If he has no funds and will work I will give him work here until he can get sufficient funds to take him to Carlisle.

Dear Ned:-

I am sorry to get reports about you which are not what they should be. A young man who has been at Carlisle five years should be able to do more than you have been doing since your return home. You are strong and able bodied and you know how to work. There is no reason why you should not put into practice what you have learned at Carlisle and make your own living and help the old folks at the same time. Instead of doing this you show a desire to live off of other people who are not as able to earn a living as you are.

You had a good record at Carlisle and I would be willing to have you return here if you want to continue your education and work at your trade. I do not want you to come back, however, unless you will come back with a determination to work harder than you ever did both in school and at your trade. We have made a splendid start in our work here this year. The boys and girls, most of them, seem earnest in their desire to get an education and are working hard. We do not want any drones here. If you want to come back and will work like the other boys and girls here, I will be glad to have you.

You think about this and then go to Mr. Henderson and ask his help. He might be able to give you work so that you

Ned seems to be deeply humiliated to think that you have a bad opinion of him and wishes me to let you know how he feels in the matter. He claims to have helped his step-father all he could. I now think that his step-father, who is a very good man, complained to me of the boy's extravagance and idleness, when he was compelled to pay \$15 to get the boy home when stranded on the way.

Ned's step-father has furnished him funds with which to pay his way back to Carlisle and Ned will leave tomorrow.
