SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the reservation school records. The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

The enrollment of Indian pupils in nonreservation schools is governed by the "Rules for the Indian Service, 1913," sections 12, 13, 14, 15, 18, 19, 36, 112, 113, 114, 117, 118, 124 (b).



My Dear Mr. Lipps:

Robert Little Hawk started for Carlisle a few days ago in response to your telegram that you would receive him. I trust that he will arrive there in due time, and this letter is to explain to you something of his home and financial conditions.

Robert is now about nineteen years old and has to his credit here \$4553.28. He also has an allotment and is heir to quite extensive real estate interests in addition.

His people are all dead except some distant relatives, the nearest probably is Henry Horse Looking, one of Carlisle's first pupils. Henry and I have taken Robert in hand somewhat and the two of us together have induced him to return. When he came home last summer I feared his physical condition was such as would cause him to go as other members of his family have gone, but at the time of leaving here he was looking quite well.


Dear Sir:





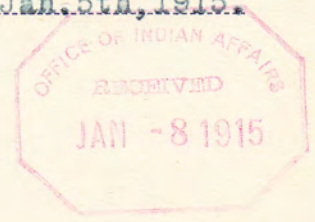
