SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the reservation school records. The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

The enrollment of Indian pupils in nonreservation schools is governed by the "Rules for the Indian Service, 1913," sections 12, 13, 14, 15, 18, 19, 36, 112, 113, 114, 117, 118, 124 (b).

The Rules should be consulted before filling out the application blanks.



Dear Mr. Parker:-

Referring to the royalty account of Jennie Feather, beg to advise that this allottee desires that check be issued from her account in the amount of \$35.00, made payable to the order of Mary Feather, who is in school at Carlisle, Pa.,

Mary Feather is the niece of Jennie Feather and Scale Feather, her husband, and when at home she lives with them, both her father and mother being dead. Jennie Feather states that she is advised by Mary Feather that her term at Carlisle will be out in a very short time, and that the school does not provide transportation for pupils to come home. It is therefore Jennie Feather's desire to have this check issued for the purpose above stated, and have Mary Feather reimburse her for the amount she is out by work or with funds whenever she may have them in her possession.

I respectfully recommend, that <sup>if</sup> the school does not provide transportation expenses, that this action be taken.
