Dear Sir:-

In regard to Fred Blythe:

If we can come to terms I shall be glad to use his services as scout leader or rather as one of my camp assistants.

In this connection however, we have made arrangements to open the camp to a younger set of boys on June 15th and 16th for three or four weeks, and then the older boys will be in camp from then until August 21st.

Our other helpers get their remuneration from the commissions they get on boys they bring with them, but in Fred's case I presume that we shall have to give him a weekly salary together with his camp expenses.

Could he come with us by June 15th? What do you think we could get him for? I think I could pay him \$10 a week in cash for the first three weeks, and possibly more for the remaining five or six weeks. I would prefer to have him the first month rather than the last if he cannot stay the entire time. You realize that it would be a vacation to him and that most boys are willing to "break even", but I am anxious to get a reliable young man who will try to stay for all the summers he is in college, so I would thank you to write me frankly on the matter,



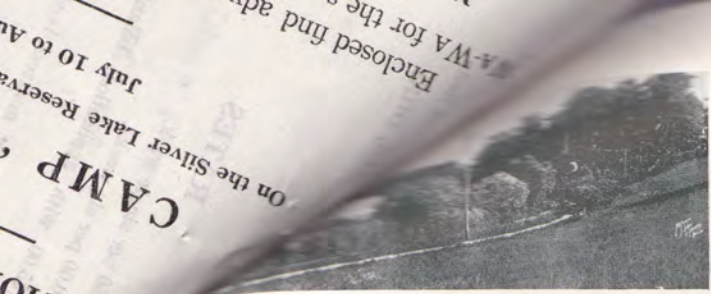

Accessible Location—Silver Lake is in Stow Township, Summit County, Ohio, nearly at the highest point of land in the State. The lake is three-quarters of a mile long and more than one-quarter mile wide. The shore line is nearly three miles.

Located six miles north of Akron, a city of 75,000, and the greatest rubber manufacturing center in the world, Silver Lake Park is at a most accessible point. Cuyahoga Falls is one and a half miles away; Kent, five miles east, and Cleveland, thirty-two miles north.

Three divisions of the Northern Ohio Traction lines run direct to the Park. The Pennsylvania Lines, also, have tracks to the Park, while the Baltimore & Ohio Railroad reaches Cuyahoga Falls, transferring passengers to the Pennsylvania there.

No intoxicating liquors have ever been sold on the grounds, and the use of liquor is strictly forbidden.

The Park has its own independent electric and water plants, as well as its own sewer system and police protection. It has also its own farm and gardens, where a large part of the fresh vegetables are raised for the dining-room and hotel. A splendid bakery is in constant operation on the grounds during the season. Sheltered pavilions contain tables, which will seat nearly 3,000 picnickers at one time. Pure drinking water is piped to all parts of the Park. No lake water is used, except





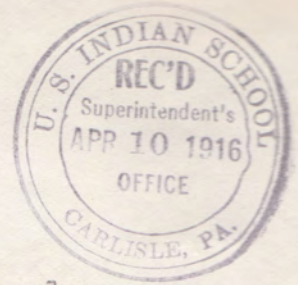
