NOTE—The Company's charge, except upon ordinary live stock, is dependent upon the value of the property, as declared or released by the shipper. If the shipper desires to release the value to \$50 for any shipment of 100 pounds or less, or not exceeding fifty cents per pound, actual weight, for any shipment in excess of 100 pounds, the value may be released by inserting "not exceeding \$50," or "not exceeding fifty cents per pound," in which case the company's liability is limited to an amount not exceeding the value so declared or released.

TERMS AND CONDITIONS.

1. The provisions of this receipt shall inure to the benefit of and be binding upon the consignor, the consignee, and all carriers handling this shipment, and shall apply to any re-shipment, or return thereof.

2. In consideration of the rate charged for carrying said property, which is dependent upon the value thereof and is based upon an agreed valuation of not exceeding fifty dollars for any shipment of 100 pounds or less, and not exceeding fifty cents per pound, actual weight, for any shipment in excess of 100 pounds, unless a greater value is declared at the time of shipment, the shipper agrees that the company shall not be liable in any event for more than fifty dollars for any shipment of 100 pounds or less, or for more than fifty cents per pound, actual weight, for any shipment weighing more than 100 pounds, unless a greater value is stated herein. Unless a greater value is declared and stated herein the shipper agrees that the value of the shipment is as last above set out and that the liability of the company shall in no event exceed such value.

3. Unless caused by its own negligence or that of its agents, the company shall not be liable for—

- a. Difference in weight or quantity caused by shrinkage, leakage, or evaporation.
- b. The death, injury, or escape of live freight.
- c. Loss of money, bullion, bonds, coupons, jewelry, precious stones, valuable papers, or other matter of extraordinary value, unless such articles are enumerated in the receipt.

4. Unless caused in whole or in part by its own negligence or that of its agents, the company shall not be liable for loss, damage, or delay caused by—

- a. The act or default of the shipper or owner.
- b. The nature of the property, or defect or inherent vice therein.
- c. Improper or insufficient packing, securing, or addressing.
- d. The Act of God, public enemies, authority of law, quarantine, riots, strikes, perils of navigation, the hazards or dangers incident to a state of war, or occurrence in customs warehouse.
- e. The examination by, or partial delivery to, the consignee of C. O. D. shipments.
- f. Delivery under instructions of consignor or consignee at stations where there is no agent of the company after such shipments have been left at such stations.

5. Packages containing fragile articles or articles consisting wholly or in part of glass must be so marked and be packed so as to insure safe transportation by express with ordinary care.

6. When property is destined to a point at which no express company has an agency it

should be marked with the name of the express station at which delivery will be accepted. If not so marked it will be carried to the express station nearest the destination point and arrival notice given consignee.

7. Except where the loss, damage, or injury complained of is due to delay or damage while being loaded or unloaded, or damaged in transit by carelessness or negligence, as conditions precedent to recovery claims must be made in writing to the originating or delivering carrier within four months after delivery of the property or, in case of failure to make delivery, then within four months after a reasonable time for delivery has elapsed; and suits for loss, damage, or delay shall be instituted only within two years and one day after delivery of the property or, in case of failure to make delivery, then within two years and one day after a reasonable time for delivery has elapsed.

8. If any C. O. D. is not paid within thirty days after notice of non-delivery has been mailed to the shipper the Company may at its option return the property to the consignor.

9. Free delivery will not be made at points where the company maintains no delivery service; at points where delivery service is maintained free delivery will not be made at addresses beyond the established and published delivery limits.

Special Additional Provisions as to Shipments Forwarded from the United States to Places in Foreign Countries.

10. If the destination specified in this receipt is in a foreign country, the property covered hereby shall, as to transit over ocean routes and by their foreign connections to such destination, be subject to all the terms and conditions of the receipts or bills of lading of ocean carriers as accepted by the company for the shipment, and of foreign carriers participating in the transportation, and as to such transit is accepted for transportation and delivery subject to the acts, ladings, laws, regulations, and customs of over-sea and foreign carriers, custodians, and governments, their employees and agents.

11. The Company shall not be liable for any loss, damage, or delay to said shipments over ocean routes and their foreign connections, the destination of which is in a foreign country, occurring outside the boundaries of the United States, which may be occasioned by any such acts, ladings, laws, regulations, or customs.

12. It is hereby agreed that the property destined to such foreign countries, and assessable with foreign governmental or customs duties, taxes, or charges, may be stopped in transit at foreign ports, frontiers, or depositories, and there held pending examination, assessments, and payments, and such duties and charges, when advanced by the Company, shall become a lien on the property.

By direction of the Secretary of War, you are hereby ordered to report to the office of this Local Board at 8:00 a m. on the 3rd day of October, 1917, for military duty and for transportation to the Army mobilization camp at Camp Punster, N.M.
(fill in with rubber stamp.)

From the date herein specified for you to report, you will be in the military service of the United States and subject to military law. Failure to report or unpunctuality are grave military offenses punishable by court-martial. Willful failure to report with intention to evade military service constitutes desertion which is a capital offense in time of war. Present yourself at the precise hour specified in order that you may not begin your military record in the service of your country with a delinquency.

You will be held under the orders of this board until the hour of departure of your train. During this period the Local Board will furnish you food and lodging. If you live within one hour's travel of the office of the Local Board, you may obtain permission to sleep and eat at home, but only if you fill out and forward to the office of the Local Board at once the printed application for this permission at the end of this sheet.

You will not be permitted to take with you on the train anything but hand baggage. You do not need bedding or changes of clothing except as specified below. You may take with you only the following articles: Soap; shaving accessories; comb and brush; toothbrush and tooth powder; towels; underclothing and socks; and if you desire, changes of collars and shirts, but you will have no use for these after arrival at the mobilization camp.

Since you will not be permitted to retain any trunks after your arrival at the railroad station, the articles listed above should be brought in a hand bundle.

If you desire to do so, you may return the civilian clothes you are wearing when you arrive at the mobilization camp to your home by express or otherwise, but if you desire to make no such arrangement, it will be better to appear in civilian clothes that you do not care to keep.

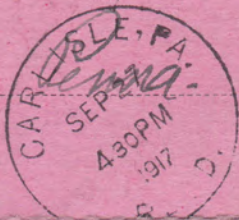

SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employe of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, that hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

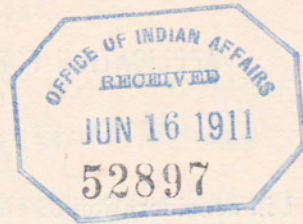

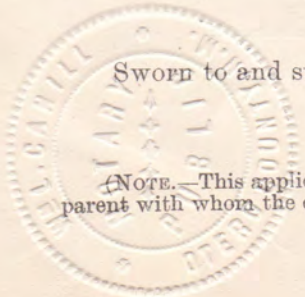

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without special permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

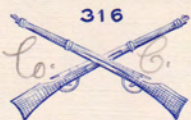

METHOD OF SENDING AND PAYING FOR TELEGRAMS.

ORDER No. 5.

TO ALL OFFICERS AND EMPLOYEES OF THE INDIAN SERVICE:

In lieu of Circular 1056, the following instructions in regard to sending and paying for telegrams, are hereby promulgated, to be effective on and after April 1, 1916:

1. HOW SENT.

No telegram on which the charges are to be paid by the Government, either directly or by way of reimbursement, shall be sent "collect" unless sent by a person not in the Service. See 3 (b).

- (a) **Indian Office.**—Messages sent by Government officers or employees to or from the Indian Office shall be marked in the lower left-hand corner, thus: "Official Business, Government day (or night) rate. Paid, charge Indian Office."
- (b) **Field Offices.**—Messages sent to or from any field office, which properly pertain to its jurisdiction, shall be marked in a similar manner: "Official Business, Government day (or night) rate. Paid, charge _____, (giving name of the person or office to which bill should be presented for payment)."
- (c) **Traveling employees.**—All other messages sent by employees who are under the jurisdiction of a field supervising office, whether sent direct to that office or otherwise, shall be marked thus: "Official Business, Government day (or night) rate. Paid, charge _____, (give name of the person or office to which the bill should be presented for payment)."

All other messages sent by employees who are *not* under the jurisdiction of any field supervising office shall be paid for in cash at the time the message is filed with the company for transmission, and the message shall be marked thus: "Official Business, Government day (or night) rate. Paid in cash by sender." In all such cases a copy of the message, showing that the original was marked "Paid in cash by sender," must be retained by the traveler and filed with his voucher on which reimbursement is requested.

2. METHOD OF PREPARATION.

- (a) **Rates.**—Each message must be marked by the sender so as to show whether it is sent at day or night Government rates. Night rates are cheaper, and should be used when too much delay is not occasioned thereby.

2. METHOD OF PREPARATION.

- (b) **Signature.**—Each telegram must be in the sender's own handwriting. Typewritten signatures must not be used. Telegrams phoned in at the receiving station of company must be confirmed by a message prepared and signed as herein directed.
- (c) **Address.**—Official telegrams sent to the Secretary of the Interior, or to the head of any bureau thereof, or to any other person in the Department whose official position is of sufficient prominence to insure proper delivery of the message at Washington, D. C., over the lines of the Western Union and Postal Telegraph Cable Companies, should be addressed "Washington" only, the letters "D. C." being eliminated. ("Departmental Order November 20, 1915.")
- (d) No duplicates should be furnished to the receiving office of the company, except to support lost messages, when ordered by the Indian Office, in accordance with paragraph 5 hereof.
- (e) **Appropriation.**—On each copy of the message give name of the appropriation chargeable with the toll.
- (f) **Form.**—When practicable use prescribed forms, making original and four copies, and disposing of the copies as marked thereon. Additional copies may be made as desired. If not practicable to use prescribed form, keep copy of the message and mail omitted forms as soon as practicable.

3. MANNER OF PAYMENT.

- (a) Vouchers of telegraph companies, when submitted for payment, must be supported by the originals of all telegrams filed by officers or employees of the Indian Service, after April 1, 1916.
- (b) Messages sent "collect" to a Government office or officer, by a person not in the Interior Department, may be paid for on presentation of a copy of the received message. However, the Government reserves the privilege of having such messages marked: "Paid, charge _____, (giving the name of the person or office to which the bill should be presented for payment)," and in such cases it will be the duty of the telegraph company to present the original message in support of its bill. Field officers are advised to instruct correspondents to so mark messages which are to be paid for by the Government.

TO ALL OFFICERS AND EMPLOYEES OF THE INDIAN SERVICE:

In lieu of Circular 1056, the following instructions in regard to sending and paying for telegrams, are hereby promulgated, to be effective on and after April 1, 1916:

1. HOW SENT.

No telegram on which the charges are to be paid by the Government, either directly or by way of reimbursement, shall be sent "collect" unless sent by a person not in the Service. See 3 (b).

- (a) **Indian Office.**—Messages sent by Government officers or employees to or from the Indian Office shall be marked in the lower left-hand corner, thus: "Official Business, Government day (or night) rate. Paid, charge Indian Office."
- (b) **Field Offices.**—Messages sent to or from any field office, which properly pertain to its jurisdiction, shall be marked in a similar manner: "Official Business, Government day (or night) rate. Paid, charge _____, (giving name of the person or office to which bill should be presented for payment)."
- (c) **Traveling employees.**—All other messages sent by employees who are under the jurisdiction of a field supervising office, whether sent direct to that office or otherwise, shall be marked thus: "Official Business, Government day (or night) rate. Paid, charge _____, (give name of the person or office to which the bill should be presented for payment)."

All other messages sent by employees who are *not* under the jurisdiction of any field supervising office shall be paid for in cash at the time the message is filed with the company for transmission, and the message shall be marked thus: "Official Business, Government day (or night) rate. Paid in cash by sender." In all such cases a copy of the message, showing that the original was marked "Paid in cash by sender," must be retained by the traveler and filed with his voucher on which reimbursement is requested.

2. METHOD OF PREPARATION.

- (a) **Rates.**—Each message must be marked by the sender so as to show whether it is sent at day or night Government rates. Night rates are cheaper, and should be used when too much delay is not occasioned thereby.

C., over the lines of the Western Union and Postal Telegraph Cable Companies, should be addressed "Washington" only, the letters "D. C." being eliminated. ("Departmental Order November 20, 1915.")
- (d) No duplicates should be furnished to the receiving office of the company, except to support lost messages, when ordered by the Indian Office, in accordance with paragraph 5 hereof.

- (f) **Form.**—When practicable use prescribed forms, making original and four copies, and disposing of the copies as marked thereon. Additional copies may be made as desired. If not practicable to use prescribed form, keep copy of the message and mail omitted forms as soon as practicable.

3. MANNER OF PAYMENT.

- (a) Vouchers of telegraph companies, when submitted for payment, must be supported by the originals of all telegrams filed by officers or employees of the Indian Service, after April 1, 1916.
- (b) Messages sent "collect" to a Government office or officer, by a person not in the Interior Department, may be paid for on presentation of a copy of the received message. However, the Government reserves the privilege of having such messages marked: "Paid, charge _____, (giving the name of the person or office to which the bill should be presented for payment)," and in such cases it will be the duty of the telegraph company to present the original message in support of its bill. Field officers are advised to instruct correspondents to so mark messages which are to be paid for by the Government.

PENALTIES

Any person who shall make or be a party to the making of any false statement or certificate as to the fitness or liability of himself or any other person for service under the provisions of this act, or regulations made by the President thereunder, or otherwise evades or aids another to evade the requirements of this act or of said regulations, or who, in any manner, shall fail or neglect fully to perform any duty required of him in the execution of this act, shall, if not subject to military law, be guilty of a misdemeanor, and upon conviction in the district court of the United States having jurisdiction thereof, be punished by imprisonment for not more than one year, or, if subject to military law, shall be tried by court-martial and suffer such punishment as a court-martial may direct. (Sec. VI, act approved May 18, 1917.)

If two or more persons conspire either to commit any offense against the United States, or to defraud the United States in any manner or for any purpose, and one or more of such parties do any act to effect the object of the conspiracy, each of the parties to such conspiracy shall be fined not more than \$10,000, or imprisoned not more than two years, or both. (Sec. 37, Criminal Code of United States.)

Whoever, having taken an oath before a competent tribunal, officer, or person, in any case in which a law of the United States authorizes an oath to be administered, that he will testify, declare, depose, or certify truly, or that any written testimony, declaration, deposition, or certificate by him subscribed is true, shall willfully and contrary to such oath state or subscribe any material matter which he does not believe to be true, is guilty of perjury, and shall be fined not more than \$2,000 and imprisoned not more than five years. (Sec. 125, Criminal Code of United States.)

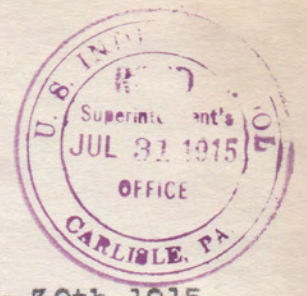

SUGGESTIONS FOR SUPPLYING THE INFORMATION REQUESTED ON THIS BLANK

1. The report of nonreservation school Superintendent should be made at the time or a little before the pupil leaves school, whether at the end of the school year or during the school year, provided the pupil is 18 years of age or over, or younger, if for any special reason the pupil is quitting school permanently. As soon as this report is received, or at least very soon after the pupil returns home, the Supervisor of Indian Employment will correspond with the returned student for the purpose of getting more in personal touch with him and finding out something about his wishes, etc. His answer will be attached to and filed as part of this report.
 2. Health, height, and weight of returned students are sometimes very important in placing them properly; height and weight could be approximated very satisfactorily, though from the pupil records now in use all information called for in part 1 of this blank can readily be obtained and be definite.
 3. The State, agency, and tribe are important, and where the pupil is not attached to any agency this fact should be stated and the Superintendent should give all available information as to the home and local conditions surrounding the pupil.
 4. Where the outgoing pupil has passed the civil-service examination for any position, this fact should always be noted, giving position for which examination was taken.
 5. It should be remembered that the Supervisor of Indian Employment can but seldom have a personal acquaintance with the outgoing student, and that he must depend on the information furnished in this report for his basis of action in behalf of the pupil.
 6. The degree of Indian blood should always be given, as this fact largely determines how much effort will be made on behalf of any particular returned student; qualifications being equal, or nearly so, the preference will be given to those having the greatest degree of Indian blood.
 7. This report should be forwarded promptly to the Supervisor of Indian Employment, Indian Office, Washington, D. C.
 8. Reports on students from reservation schools should be made only as to those who leave the schools at 18 years of age, or older, and who will probably not go away to school.
 9. If part 1 of this report is made out by the principal of a reservation school, the reservation Superintendent should supply information called for in part 2 if the principal is not informed as to home surroundings and local conditions. Such information is essential to a proper understanding of the difficulties and needs of the pupil.
 10. When part 1 is made out by a nonreservation Superintendent, this blank will be sent by the Supervisor of Indian Employment to the Superintendent of the reservation where the outgoing student belongs. He should fill out part 2 and return the blank as promptly as possible, for practically nothing can be done until the information called for in part 2 is supplied.
- Information under the heading "Employed since return as follows," will be valuable only in cases where the pupil has been home for some time.

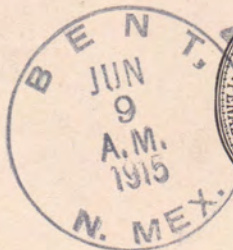

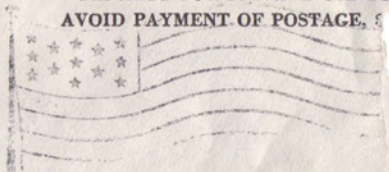
