INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

I received the Christmas present sent to me by the Indian School Branch of the American Red Cross and I was surely glad,

We had quite a snow storm here today, there is about 8 inches of snow and at the same time it save the day, we didn't have to drill, but when we do drill, we drill 8 hours a day. It has been so cold that three or four of the boys froozed to death, boys that came from the Gulf States. In some of the bungalows, the steam pipes were out of order and that made the room that much colder.

We moved from the other camp yesterday and came to camp Lawrence.

I hope you will excuse me
for writing with pencil as ink
is hard to get in these training camps
I will get some ink when we're
granted our liberty.

My dear Sir:

When Levi Jamison was seen at this office regarding the land sale you brought to my attention in your favor of August the 3rd he stated that the land in question was purchased for him by his mother from Mr. Eli Printup and that she paid an amount of \$75.00 for it. He also stated that he was willing to sell it because it is "way back in the woods" and because Mrs. Carrie Jones would not let them cross her land to get to it. It seems that the tract adjoins land belonging to Mr. Printup and that he can get to it without crossing other owners' land.

Levi understood that an amount of \$70.00 was to be paid for the land by Mr. Printup in amounts of \$40.00 and \$30.00 in April and December, respectively.

When he was questioned further about the sale he declared that he wanted it sold because of the difficulty with Mrs. Jones, and as near as it can be determined now he is yet in favor of letting the sale go thru.



Dear Sir:- Complaint has come to me from residents of the Tonawanda Indian Reservation that an attempt has been made to get certain land owned by Levi Jemison away from him. Jemison is a student at your school but is a Tonawanda Indian formerly residing here. I am, by virtue of the Indian Law of this State, attorney for the Tonawanda Indians. It has been reported to me that Mr. Eli Printup, a well known member of our Nation, has purchased this land and now claims to own it. I have seen Mr. Printup this day about the matter and he tells me that he did contract with Jemison and his sister, Abbie Jemison, residing on this Reservation, aged 29, who claims to be the guardian for this boy, self appointed. This conversation took place last fall, all three being together at the time, in which Mr. Jemison and his sister said they wanted to sell a little piece containing about four acres of Reservation land and Mr. Printup wanted to buy. The price was \$75.00, \$40.00 to be paid April 1st., last and \$35.00 next December, none of which has been paid, because, as Mr. Printup states to me, he is willing to pay at any time and has the money on hand but there has been some talk about the matter on the Reservation and he didn't want to have any trouble about it. This land was some given to Jemison by his mother now deceased. Mr. Printup has had his title recorded on the Clerk's Book of Records in his own name. I have talked with Jemison's sister, Mrs. Carnon and with his aunt, Mrs. Charles and they told me that they supposed Jemison still owned the land and that they wanted him to continue to own it until he became of age, as it would be of more use to him when he came out of school than the money would be now. Will you kindly take this matter up with Jemison very carefully in detail and write me the exact truth about the matter from his standpoint, as to whether he actually did contract to sell the land to Mr. Printup or not, the price, the terms, whether he really intended and desired to sell it himself, or whether it was his sister Abbie who wanted to sell it. Try to find out just what this boy wants to do with his land as near as you can so that we can settle this controversy here and either permit Mr. Printup to keep the land and pay the money for it or give it up. Mr. Printup has a crop of oats on the land this year and of course wants to have the matter settled.






