SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the reservation school records. The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them are living, and if neither of them are living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservation, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservation. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

That no Indian pupil under the age of fourteen years shall be transported at Government expense to any Indian school beyond the limits of the State or Territory in which the parents of such child reside or of the adjoining State or Territory. (35 Stat. L., 781.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other nonreservation school without the consent of both superintendents and the Commissioner of Indian Affairs, and superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case but in all cases where the parents are living they should first be consulted.

This form is to be used only in transfers from reservations or Indian schools to nonreservation schools.

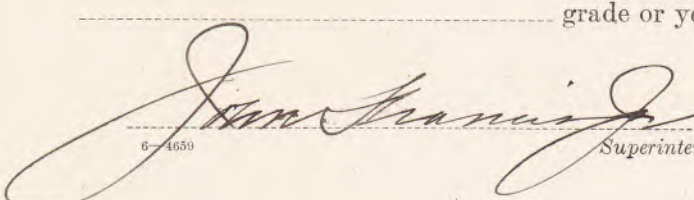

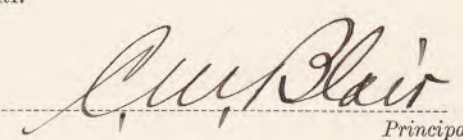

Dear Mr. Lipps:

Referring to your letter of the 14th instant, enclosing a telegram from Mrs. Lillie Blake, requesting that her son Robert be permitted to return home, immediately upon receipt of your letter I wrote Mr. J.L. Hale, the Probate Attorney at Poteau, and requested that he advise me of the facts in the case in order that a recommendation might be made to you. I am just in receipt of a letter from Mr. Hale, advising that he will make a full report within a day or two, but he suggests that by all means the boy should remain at Carlisle.

In view of the preliminary report from the Probate Attorney, I would not recommend that Robert be permitted to return home at this time. As soon as I have further advice in his case I shall write you again.

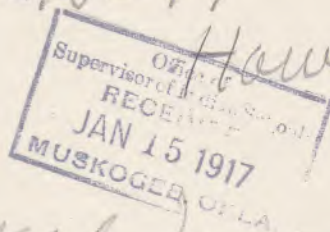

This letter from her prompts me to ask if the seventeen vacation students named in your letter of August 14 have funds at your school sufficient to pay their return transportation. If so, it is suggested that you place prepaid order for their tickets from Muskogee to Carlisle and let the students be required to pay their transportation from their home railroad points to Muskogee, taking railroad receipts so that they may be reimbursed by you after reaching Carlisle.

Kindly advise by wire, if necessary, so that we may send notices to the students.

I am in receipt of your letter of recent date enclosing one from Mrs. Lillie Blake, whose son Robert is a pupil of this school.

You can tell Mrs. Blake that we had a case of small pox at the school but the boy who had it is very nearly well now. The school was under quarantine for several days but this was lifted yesterday.

The hospital which is some distance away from the buildings where the pupils live, is still under strict quarantine. All pupils and employees who have not been vaccinated with the last five or seven years, were vaccinated, unless they showed a good mark on the arm.

You can assure Mrs. Blake that every precaution has been taken to prevent the spread of the disease and that at present Robert is in good health. I enclose her letter to you.

VACATION REQUEST FOR PUPIL.

We, the undersigned, respectfully request that leave of absence be granted to our son -
Robert W. Blake to spend the vacation at home
 from June 1st or 5 1917 to September 1st or the 5 to
 enable him to visit his home. We hereby agree to pay all expenses, including
 round-trip railroad fares, sleeping-car fares, meals, lodging, stage fares, telegraph and telephone messages,
 and other incidental expenses connected with the visit. We further agree that said pupil shall be
 returned to the Carlisle Indian school on or before the last day of the leave of absence.
 We further agree to deposit with the superintendent of the school sufficient money to defray all expenses
 to be incurred, and should the pupils, or any one of them, fail to return to school at such time as may
 be agreed upon by the parents or guardian and the superintendent of the school in which the pupils
 are enrolled, the amount of money remaining with the superintendent, necessary to the return trans-
 portation of the pupil or pupils so neglecting to return, shall be forfeited to the Government; provided,
 however, that in all cases where it can be shown that there were justifiable reasons for the failure of the
 return of the pupil the forfeiture of the funds shall not take place.

If the pupil neglecting to return is from a reservation, the superintendent of the reservation shall
 certify to the reasons for the nonreturn of the pupil or pupils. If a pupil's home is not on a reservation,

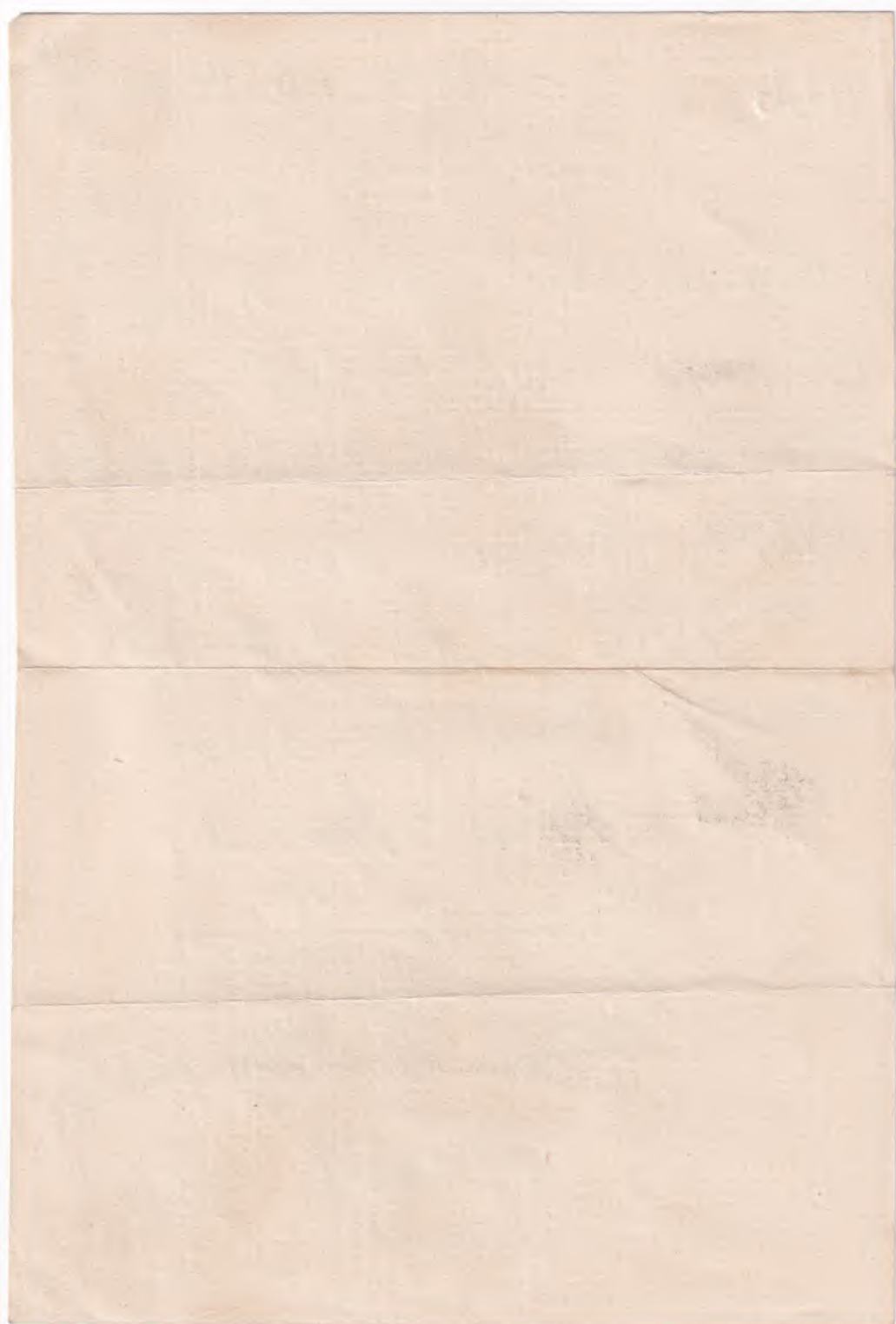

nothing further to do in this case and I therefore recommend
that he be permitted to come home. If the school has
advanced any funds to pay transportation for him or for
any other purpose his parents should be required to reimburse
you before Robert leaves.
