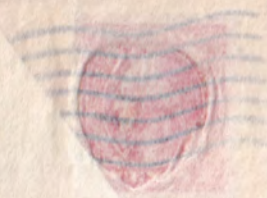

SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a nonreservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the reservation school records. The reservation superintendent should send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

If the information called for on any part of the blank is not known, that fact should be stated. No space should be left unfilled. Whether the parents are living or dead, their names must be given.

The person who signs the blank as consenting to the transfer should indicate his relation to the applicant by marking out the word "parent," "guardian," or "next of kin," leaving unmarked only the title appropriate to the signer.

CERTIFICATE OF AGENT OR BONDED SUPERINTENDENT

I hereby certify that the statements made in the foregoing application and certificate to the Agent or Bonded Superintendent are true and correct, and that the child named therein is a bona fide Indian pupil of a reservation school, and that the child is in good physical condition for school and not afflicted with tuberculosis or any disease which would be a menace to the health of other pupils.

The enrollment of Indian pupils in nonreservation schools is governed by the "Rules for the Indian Service, 1913," sections 12, 13, 14, 15, 18, 19, 36, 112, 113, 114, 117, 118, 124 (b).

The Rules should be consulted before filling out the application blanks.

SPECIAL NOTES

This form shall be completed in duplicate when a child is transferred from a reservation school to a nonreservation school. The original of the application shall be retained by the school and the duplicate shall be retained by the nonreservation school. The nonreservation school shall forward the duplicate to the Commissioner of Indian Affairs as soon as possible. All the blanks shall be properly filled in every case. If the nonreservation school has no agent or bonded superintendent, that fact should be stated. Response blanks to be filled. Whether the parents or legal guardian of the child is a nonreservation school, that name should be given. The parent and agent of the child are essential to the transfer and the application to the agent by the parent or legal guardian. Whether the parents or legal guardian of the child is a nonreservation school, that name should be given.

INFORMATION REQUIRED UNDER DECLARATION OF POLICY

13

Elimination of Ineligible Pupils from the Government Indian Schools.—In many of our boarding schools Indian children are being educated at Government expense whose parents are amply able to pay for their education and have public school facilities at or near their homes. Such children shall not hereafter be enrolled in Government Indian schools supported by gratuity appropriations, except on payment of actual per capita cost and transportation.



I have your letter asking that \$50.00 be transferred to you to pay your expenses from Carlisle to your home. I have just recently received information from Washington that Carlisle is to be abandoned, and that all pupils will be either transferred to other schools or sent home. I presume that the expenses of such transfers will be paid by the government, and as the school will, no doubt, be closed at an early date, I do not think it advisable to transfer any funds to this school for you at this time.


