INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

I am Mrs Alice E. Patterson of
Living N. Y. mother of Robert & Bunuel Patterson
First of all I want to thank you & your Co-wo-
rkers for what you have done, & are doing
for my boys. Their monthly reports have been
fine & I feel that a great deal of interest
have been shown them & that they have
both been trying to make good, for which
I am very grateful.

Now that Spring is so near at hand & as
you are preparing to send the boys in the
country homes, I thought I would explain
to you just how I am situated. Mr P. is
sick in bed with Endocarditis or heart dis-
ease & is failing fast & I am caring for him
all alone. Robert & Bunuel are the only ones
I can depend on, and as Robert is in the
Prevocational class of boys & will have his
examinations in the last week of March
& then there will be no school for the prevo-
cational boys after Apr 1.st. I thought I would
like to have Robert come home so he can help
me this summer & then in the fall return to the

School. I fully believe in keeping my boys in school as an education is something no one can take from you. The high cost of living & this dreadful War situation has made it hard for every body and especially those with meager means. I want to put in a garden and some potatoes & various other things & find that it is impossible to do it all alone & need Robert to help me. No one is earning anything at present Mr P. has been sick & unable to work since last May almost a year & I am caring for him night & day and doing the house work besides. I want Burrell to finish at Carlisle & fit himself for a position in life, likewise Robert. Could you arrange for his transportation if providing my plans are agreeable to you. My daughter graduated in 1906 from Carlisle and took a Civil Service examination & was sent to Isletā N. Mexico to teach among the Pueblos she was the youngest pupil to graduate at Carlisle only 14 yrs old & was there only 8 months she was Rosabelle Patterson then, but is now Mrs Mitchell Pierce. They are getting along nicely he is an automobile mechanic at present they are on his fathers farm but expects to return to Buffalo & resume his trade. Please let me hear from you. Thanking you again for past kindnesses. I remain Very Respectfully Yours.
