SOMEWHERE IN FRANCE..

July 29, '18.

My Dear Neice,

I am just sending a short letter to say I am well and hope you are the same. Mary was telling me that you girls were near together and were having a good time. I am glad you girls have such nice places and hope you will always have such nice homes. I received the pictures Mary sent me; you girls look fine in it. I would like to see you girls now, I suppose you have grown to be big girls.

My sister Margaret wrote and told me that Marion had arrived home and was getting along well. I am glad she went home so she can help Mother this summer, but I hope she will give up school. Frank said he was going to send her back to Carlisle, in the fall. Did you hear about school being turned into an Army Hospital? I saw it in the paper and was very much surprised. If that's the case you people will have to go home till the war is over. I hope they let you girls stay out in the country instead of sending you home, don't you? When we get back to the states again I am going to see you and I am sure Peter will go with me. Won't that be great?

Do you play the piano yet? I hope you do so when I get home I shall have you play for me. I still have my violin and I play on it every day. I play a great deal better now. I hope you will be able to play with me when I get home.

On the 4th of July, a bunch of fellows went on our leave for seven days and we had a fine time. We went to a summer resort down in the southern part of France and it was the most beautiful place I ever saw. We had all the swimming we desired and took some fine trips up to the mountains. One day we took bicycles up with us and when we were ready to come back we coasted back to town of about 15 miles. There was always something doing and we were on the go all the time. We celebrated the FOURTH in that town and we had lots of Ice-Cream, everyone enjoyed themselves. On the way back we stopped at Lyon and celebrated the FOURTEENTH. It was there that a fine new bridge was named after our president. They named the bridge "PONT WILSON". The Americans were the first ones to cross it. We were very proud of it. Peter went on his leave after I had come home so I did not get to see him. I hope you girls had a good time also. We are once more back into harness and in four months we shall be able to go again.

Don't forget that I am always to hear from you and to know how you are. Give my love to Mary.

I was late with
my letter to Mr. Peel which

He did not hear from
Hattie's mother until last
Thursday. We have had
a series of circumstances

as my letter didn't get written.
It would grieve me
terribly to let Hattie go
this year for in all prob-
ability it would mean
her downfall. I have written
Mr. Peel what a bad home
she came from. Please
don't let him interfere
with her progress. How
unfortunate Mr. Francis
is away. It did not occur

read it! you will see the
picture it suggests. If
Hattie works, she will stay
home. The father drinks

You know it is a
matter of conscience with
me to send the girls out
from here physically
well as far as possible.

I know Mr. Pul will not
prevent Hattie from get-
ting the attention she needs
when she understands
the situation. Dr Fox is

he returns I will have
him examine her again.
The lump in her throat
is growing & she has
great difficulty in
swallowing without some
liquid to help the food
down, also great diffi-
culty in sleeping - can't
get to sleep sometimes for

Katie here out of posses-
sion - It would be inhuman
of me to send her away, un-
less it would be to a hos-
pital. She is not in
condition to live in any
school until she is at-
tended to. If Katie's
father wants her it

her from him - Conditions
here are immoral too
What is there in the world

INDORSEMENT.

A child showing one-sixteenth or less Indian blood, whose parents live on an Indian reservation, Indian fashion, who, if debarred from the Government schools, could not obtain an education, may be permitted in the reservation day and boarding schools, but it is preferable that it be not transferred to a nonreservation school, without permission from the Office. Children showing one-eighth or less Indian blood, whose parents do not live on an Indian reservation, whose home is among white people where there are churches and schools, who are presumed to have adopted the white man's manners and customs, and are to all intents and purposes white people, are debarred from enrollment in the Government nonreservation and reservation schools. Superintendents, in all cases where doubt exists as to the degree of Indian blood of a child proposed for transfer, should fully satisfy themselves of the facts by affidavits from reliable persons, which affidavits must be kept on file at the school.

A pupil who has been regularly enrolled in a nonreservation school must not be taken to any other non-reservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

A pupil dismissed from school for cause must not be enrolled in any other school without the permission of the Commissioner of Indian Affairs. Full facts must be submitted with each request.

Dear Mr. Francis:-

Do you wish Hattie Tarbell to remain under the Outing this winter in Mrs. Comfort's home? If after considering the following you so desire will you notify either Mrs. Comfort or myself by Thursday morning.

The home is all right - school advantages excellent - Hattie was in Room 4 1/2 in Carlisle.

During the three summer months Hattie has taken various sums of money. \$4.50 is known definitely. You have her July report. She has used innumerable ways and means to cover and deceive. The child hardly seems to know what "truth" is. Hattie wants a good time by hook or by crook. A good time is her aim. She has an agreeable disposition - is not pouty nor sullen.

Father Caranough, at Mrs. Comfort's request, made a call on Hattie on Friday and gave her a strong talk. Mrs. Comfort feels that what Hattie needs now is a close following up by much personal help and influence. She thinks punishment would not reach her at all.

Hattie says she is very sorry for her misconduct and I told her she should stay with Mrs. Comfort and prove by her actions that she was sorry. She says she wants to remain with Mrs. Comfort but I presume, this may be because of the fear of the disgrace upon reaching Carlisle.

Would Carlisle with all the enthusiasm he best for her now? Would she forget the lessons of the past few weeks were she to return with all the excitement?

Hattie is boy-struck as is evidenced by these numerous calls from the boys this summer and her voluminous correspondence. A sample is enclosed.

From a physical standpoint:- Hattie has a large goitre which Dr Fox said early in the summer should and could be removed soon. It looks bad and causes difficulty when she swallows. The poor child has to leave the table to wash the food down her throat. Sometimes it chokes her at night. One ear is quite deaf. She also has a habit of walking in her sleep. Mrs Comfort had her eyes attended to very soon after she came out.

To return to the boy visitors:- Warren Large, Lewis Bero and Richard Bluffing Bear were the other visitors. Eli Washington and Richard Bluffing Bear also called on Isabel Rose. Her country mother sought advice from Mrs. Comfort. Isabel was in no way to blame. I understand these same two boys, Eli and Richard, also called on Minnie Loren at Orient, N. J. I will not be able to see Mrs. Smith as to whether or not she has reported it.
