SPECIAL NOTE.

This form must be executed in duplicate when a child is transferred from a reservation to a non-reservation school. The Superintendent of the nonreservation school will retain the original for his files, and the duplicate shall be deposited in the Agency records. The agent will then send to the Commissioner of Indian Affairs his certificate as provided by law. All the blanks must be properly filled in every case.

NOTE.—Age limits, fourteen to twenty years. Preferably fourteen to eighteen. Students must be at least one-fourth Indian, preferably full Indian. Special cases beyond the age limit will be given consideration. An industrial course only can be taken and the term reduced to three years, in exceptional cases.

INDORSEMENTS.

The laws relating to the transfer of Indian children from reservations and schools are as follows:

That hereafter no Indian child shall be sent from any Indian reservation to a school beyond the State or Territory in which said reservation is situated without the voluntary consent of the father or mother of such child if either of them is living, and if neither of them is living without the voluntary consent of the next of kin of such child. Such consent shall be made before the agent of the reservations, and he shall send to the Commissioner of Indian Affairs his certificate that such consent has been voluntarily given before such child shall be removed from such reservation. And it shall be unlawful for any Indian agent or other employee of the Government to induce, or seek to induce, by withholding rations or by other improper means, the parents or next of kin of any Indian to consent to the removal of any Indian child beyond the limits of any reservations. (28 Stats., p. 906.)

Provided, That hereafter no Indian child shall be taken from any school in any State or Territory to a school in any other State against its will or without the written consent of its parents. (29 Stats., p. 348.)

The rules provide that—

A pupil who has been regularly enrolled in a nonreservations school must not be taken to any other nonreservation school without the consent of both Superintendents and the Commissioner of Indian Affairs, and Superintendents will be held to strict accountability for such pupils taken to their schools.

An Indian boy or girl 18 years old and over may, without the consent of parents or others, personally sign the application form on its being changed to suit the case.

This form is to be used only in transfers from reservations, or Indian schools, to nonreservation schools.

I am writing this letter concerning my daughter Cynthia, of coming home this summer. It was understood when my daughter was admitted to the school, she was escorted by one of your school matrons. I told her that the child was not in fit condition for that school, she made an examination, saying the child would be all right in a short time. I am getting reports from the school that the child is doing well and in good health, but at the same time I am getting letters from my daughter claiming she

was told that she would have to go through an operation of some kind. The matron that escorted the child to school said that if the child is not going to get well she would be send back home. I understand she has gone through one operation since she has been there, without lettering me, ^{know} her condition I should think you ought to get the consent from me concerning the operation.

You will kindly consider this request you will oblige

I am in receipt of your letter, also the "vacation blank" for me to sign. I decline to sign the request blank for the reason that I think Cynthia should not return to school so soon. If she is well enough in about a year from next fall, if she wants to she can go back and finish.

And I am not over loaded with money times are hard here, my wife is sick, and I spend a good deal of money for doctors fees etc. And I think it is enough that I paid Cynthia's way over there last fall; so I earnestly request Uncle Sam to pay her way back this time. Other children have been returned, (that were sick) under government expense. Such as Lillian and Freeman Parkhurst.

So I would consider a great favor
on your part to send her, immediately,
on your own expense, or rather of
the government.

Dear friend,-

I have your letter concerning your daughter Cynthia and have found out from our school doctor, just what her trouble has been. He says that the swollen gland about which you knew, broke out again. He said it was necessary for him to open the gland slightly to allow the discharge to drain out more readily. There was no operation.

Cynthia is attending school regularly now. I will ask the matron to watch her carefully and try to help her build up.

If you wish to have her spend her vacation with you, I would have no objection to her doing this. I sent you a Vacation Request Blank which you can sign and return to me. School closes the 6th of June, after which time, I can arrange for her to go to you, provided the money for her fare is deposited here. You will note that you have to deposit her return fare also.

I hope this report about your little girl will be satisfactory and that you will feel satisfied that we will take good care of her.

As you have not seen your daughter lately, it is very evident that the Superintendent is better advised concerning her physical condition than you can be and you have doubtless been misinformed as to the seriousness of her condition.

The requirement that you deposit funds to cover the expense of your daughter's trip home for the summer is in accordance with Office instructions and is not an expedient resorted to by the Superintendent to get you to take your daughter home because she can no longer work. A copy of this letter will be sent to Superintendent Francis who will advise you if at any time your daughter's condition becomes serious.

Sir:-

I am in receipt of a letter addressed to you by Sampson W. Cornelius, West Depere, Wisconsin, father of Cynthia, a pupil of this school. He wants his daughter at home and believes that since the school doctor here has recommended that she be sent home, this ought to be done at government expense. He thinks it is enough that he paid the girl's fare to Carlisle when she enrolled.

Mr. Cornelius paid the girl's fare to Carlisle last fall because she was under age and the government could not do it. She was in good health until early this spring when a gland on her shoulder which had given her trouble before she came to Carlisle, broke out again. The doctor opened it and drained it and he reports that it is healing nicely. He reports this morning as follows:

"I have the honor to report that Cynthia Cornelius is in good health and there is no cause for alarm whatever. We can and are taking as good care of her here as could be done anywhere. She does not receive any special treatment and the sore on her shoulder is healing nicely. Cynthia comes to the hospital once a day in the morning to have the dressing changed. She is at work and at play the rest of the time just the same as the other girls."

We have no objection to Cynthia's spending the summer at home with her parents but they have refused to comply with our regulations regarding the deposit of money to pay expenses and have also refused to sign the Vacation Leave of Absence. They seemed so insistent that on July 3rd I wrote them that if they would send the fare one way, I would return Cynthia to them.
